  - A. The group reviewed an updated draft of the <u>Agenda Item Request (AIR) Form</u>; the recommended changes will provide more information and data when requesting new funding or a contract renewal

#### A. Early Intervention Court

- 1. Early Intervention Court (EIC) is a voluntary non-statutory "pre" and "post" plea program that offers participants options to avoid a felony conviction through successful completion of a series of programs centered on personal and professional development; the program is currently contracted through Leaders in Community Alternatives (LCA)
- 2. The recommended <u>Early Intervention Court Logic Model</u> was shared and discussed, including the target population, what the program offers, and the short to long term results the program hopes to achieve; one of the participants shared her EIC experience with the group

#### B. For Us By Us (FUBU) Peer Mentorship Program

- 1. FUBU helps disengaged clients reconnect and integrate back into the community by providing lived-experience peer support that utilizes supervision, stabilization services, training, and leadership development opportunities; a major change to the program and accompanying logic model is the expansion of services to clients who are new to supervision, in addition to those who are disengaged; the program currently has four contracted providers who help connect clients to services throughout the county: Building Opportunities for Self-Sufficiency (BOSS), Community & Youth Outreach (CYO), Men of Valor Academy (MOVA), and Tri-Cities
- 2. A recommended <u>FUBU Logic Model</u> was shared and discussed; this logic model is for a *new* Request For Proposal (RFP), so the future contract may or may not include the same providers
