II. <u>REVIEW AND APPROVE MEETING MINUTES</u> – Meeting minutes from February 25, 2021 were reviewed and approved as written

III. SANTA RITA JAIL TABLET PROJECT – Justin Eaglin, Acting Unit Supervisor, PRCS Adult Field Services

- A. Visitation has been suspended at Santa Rita due to COVID-19; to cover the gap in provider services, clients are being given tablets tied to the jail phones and can be used for 3 calls
- B. Flyers have been shared with the Probation clients, and if successful, will then go to non-Probation clients
- C. Service providers are being given Probation office space, and each provider will have a designated time and space to use for meeting with their clients via the tablets; service providers can contact Justin Eaglin (jeaglin@acgov.org) and Director Henzi (chenzi@acgov.org) to be added to the list for space and time
- D. There is still no word yet on when visitors will be allowed to enter the jail

IV. <u>A SAFE PLACE REENTRY PROGRAM</u> – Carolyn Russell, Executive Director and Denise Moody, Reentry Case Manager

- A. A Safe Place was initially established in downtown Oakland as a place for battered women; it also has a confidential emergency location
- B. The reentry program began because many women who are part of the reentry community are domestic abuse survivors; often domestic abuse survivors are arrested for defending themselves
- C. Most survivors have a need for mental health services; A Safe Place provides those services, taking them directly from Santa Rita, and focusing their work on reducing the client's trauma
- D. A Safe Place's hotline gets calls for shelter and other services, including mental health crisis; clients are housed in a motel program and their needs are assessed; there are resources for men and children
- E. Twice a year there is a 40-hour domestic violence training program for professionals and volunteers; Mental health services are located at the Community Center; serve both adults and children
- F. Deep East Oakland has the most cases of domestic violence in Alameda County; A Safe Place is working with youth on the issue

G. A Safe Place has connections to transitional housing, but housing is still a huge challenge; it's important for providers to work together on services, especially housing; Denise Moody can be reached at dmoody@asafeplace.org

V. PROGRAMS AND SERVICES WORKGROUP PURPOSE

- A. Goals of the Public Safety Realignment Act, AB 109: (1) reduce the prison population, (2) reduce recidivism, and (3) reduce corrections spending
- B. The Community Corrections Partnership (CCP) was tasked with developing a Realignment plan and the Community Corrections Partnership Executive Committee (CCPEC) was tasked with oversight, implementation and assessment of the plan
- C. CCPEC Workgroups:
 - 1. Data and information Management Workgroup: Design and develop a comprehensive, integrated data management system that allows tracking of individuals, outcomes, and costs
 - 2. Fiscal and Procurement Workgroup: Develop an annual Realignment allocation plan and procedures for effective and efficient procurement
 - 3. Process and Evaluation Workgroup: Define and develop the plan for, implementation, and evaluation of, Realignment activities in Alameda County
 - 4. Programs and Services Workgroup (P&SW): Ensure availability of, and access to, effective, results-oriented services for Realignment populations from the continuum of charging through successful reentry
 - 5. P&SW Objectives: Catalogue existing programs and services; Identify service barriers; Fill gaps and augment existing services; Increase effectiveness and enable reporting of county-wide EBP's by enhancing and supporting the use of EBP's across all agencies and providers; Expedite service delivery to improve outcomes and facilitate and support reentry and rehabilitation
- D. New Program Ideas: Evaluate current programs and needs to identify gaps; identify clear program goals and target population; ideas go from the P&SW to another CCPEC Workgroup (if needed), then to the Community Advisory Board, the CCPEC and Board of Supervisors; Project development, contracting and implementation begin after approval
- E. Discussion:
 - 1. There's a role for the P&SW to have an on-going agenda item around the work of the CCP and implementation of the Adult Reentry Strategic Plan; the P&SW can play a role in monitoring the implementation process since the CCP does not meet as regularly
