Alameda County SSI Advocacy Outcomes


Started January 2012

\$22M in retroactive SSI benefits to clients

\$84.4M to clients in ongoing SSI benefits

Client Outcomes - Recidivism

- Comparing 12 months prior to and 12 months after receiving SSI benefits:
- **70.9% of clients experienced fewer Incarcerations**




Impact of Disability Benefits on Jail Recidivism

Client Outcomes - Mental Health


- Comparing 12 months prior to and 12 months after receiving SSI benefits:
 - > 79.2% of clients experienced fewer Psychiatric Emergencies (5150s)
 - 80.2% of clients experienced fewer Hospitalizations

Social Security Disability Benefits

SSI (Supplemental Security Income):

- Federal benefit of last resort for people who are disabled or older (65 or over) with limited resources
- Provides monthly cash assistance to people who are unable to work due to a health condition expected to last 12+ months
- Average \$910/month

SSDI (Social Security Disability Insurance)

- Insurance program paid into while working
- Monthly benefit amount depends on how much you earned and how recently you worked

How long does the SSI process take?

- File initial application
- If denied, file reconsideration
- If denied, file hearing request

- 6 12 months for decision
- Wait 6 12 months for decision
- Wait 9 18 months for a hearing before an ALJ

- 1. Disability Attorneys
 - Pre-Release Representation in Santa Rita Jail
- 2. Integrated Health Care Clinic
- 3. Mental Health Services with Case Management
- 4. Increased Interim Assistance

1. SSI Advocacy

- Began January 2012 with 26 attorneys
- Current Capacity: 75 attorneys x \$55,000 per FTE
 - ▶ 50 FTE Social Services
 - ▶ 13 FTE BHCS
 - ▶ 12 FTE Reentry
- Funding
 - 50% Federal Reimbursement County Service Block Grant
 - County General Fund
 - Mental Health Services Act
 - ► AB 109

Reentry SSI Advocacy

- In February 2016, SSI Advocacy expanded to focus on the reentry population with AB 109 funds
- Pre-Release Application Process
 - 12 attorneys conduct in-reach at Santa Rita Jail
 - ► Who do we meet with?
 - Why apply for SSI pre-release?

Reentry Clients Served Since 2016

- 466: Pre-release SSI applications for inmates at Santa Rita Jail filed
- 72: Applications for 72 people recently released from Santa Rita Jail filed
- ► 95: SSI Approvals

2. Mental Health Services with Case Management - Bay Area Community Services

- 5 Case Management Units
 - ▶ 1 Supervisor, 3 Clinicians, 3 Peers with lived experience
 - 80 Client Caseload per Unit
- Services:
 - Coordinate care, assist with housing, maintain contact with attorney
- Funding
 - Mental Health Services Act (4 Units), AB 109 (1 Unit)
 - Leveraging Medi-Cal (Specialty Mental Health Services)

3. Integrated Primary Care and Mental Health Clinic - TRUST Clinic

Goals


- Integrated care to mitigate disparities in care for people with mental health issues
- Document Functional Limitations
- Harm Reduction

Funding

- Federally Qualified Health Center
- Mental Health Services Act

4. Increased Interim Assistance

- Extra \$318/month on top of General Assistance (\$336) & Food Stamps
- Provide the benefits of SSI income while waiting for SSI



- 77.3% experienced fewer Psychiatric Emergencies (5150s)
- 69.6% experienced fewer Psychiatric Inpatient Stays
- 75.0% experienced fewer incarcerations

61% reduction in cases closed without securing disability benefits

Unmet Need for Reentry SSI Advocacy

- 6,637 people incarcerated in Santa Rita in the last 2 years have been identified as disabled and do not currently have Disability Benefits
 - 2,816 of these individuals previously received SSI
 - 2,234 must start SSI advocacy process again (because 12+ months have elapsed since discontinuance)
 - 582 are eligible for reinstatement (because within 12 months of discontinuance)
- 869 (13.1%) are currently represented by an SSI attorney
 - 432 Advocacy Slots are funded by AB109 (with leverage)
