SUBJECT: PROCUREMENT UPDATE

Attached is an updated progress report on County Procurement. The data presented in the report is for the period July 1, 2009 through June 30, 2015. The information presented in this report is based on payments made to contractors. As you can see on Page A from the summary chart of all payments up to \$500,000 dollars for the period July 1, 2009 through June 30, 2015:

- Total payments up to \$500,000 were \$626.3M
- \$421.5M was paid to local contractors which equals 67.30% of total dollars up to \$500,000
- \$328.3M was paid to MWBE/SLEB contractors which equals 52.42% of total dollars up to \$500,000
- Payments to MWBE/SLEB contractors by category were:

Construction:	\$39.6M which is 51.20% of Construction dollars
A & E:	\$7.4M which is 44.21% of A & E dollars
Professional Services:	\$111.9M which is 62.23% of Professional Services dollars
Goods & Services:	\$169.4M which is 48.03% of Goods & Services dollars

Also included in this report are all payments to contractors including amounts over \$500,000. This information is presented in the summary on Page B.

- Total payments were \$1.40B
- \$918M was paid to local contractors which equals 65.38% of total dollars
- \$497.1M was paid to MWBE/SLEB contractors which equals 35.41% of total dollars

## ***Vendor Survey Update***

- On July 1, 2015 approximately 27,000 supplier questionnaires were mailed out
- Approximately 4,825 responses have been received (17.8%)
  - Mail Responses – 2,989 (11.1%)
  - On-Line Responses – 1,834 (6.8%)
- Approximately 6,500 questionnaires were returned as undeliverable
- Staff received over 800 phone calls related to the survey; 400 phone calls resulted in actions to the database
- Analysis is underway on all responses & undeliverable mail
