 - B. Authorize the execution of a land Conservation Agreement (Williamson Act Contract) with Matthew N. Morris and Jennifer D. Spriggs restricting one parcel totaling 71+/- acres of land located at 5863 Collier Canyon Road in unincorporated Livermore (APN 903-1-8) to agricultural, open space, and compatible uses, for a term effective 12/8/22 until either party serves written notice of non-renewal, with no financial terms.

PLN2021-00096 - SITE DEVELOPMENT REVIEW - BHULLAR / OUTFRONT MEDIA - Proposal to remove 5 static billboard structures with 10 signs from 4 locations, and to construct and operate an 80 ft tall electronic billboard sign, in the "CN-C" (Corridor Neighborhood Commercial, ACBD Specific Plan) District, located at 17338 Langton Way, east side, 100 ft north of Lewelling Blvd, Ashland Area of unincorporated Alameda County, APN 414-0006-045-02.
