**Subject: Salary Ordinance Amendment** 

Dear Board Members:

#### **Recommendation:**

Adopt a Salary Ordinance amendment establishing four new Vector Control job classifications, Vector Control Manager, Supervising Vector Control Biologist, Senior Vector Control Biologist and Vector Control Biologist, to handle increased complexity in the scope of work and expertise required, including supervision and management, in the Vector Control program of the Health Care Services Agency.

### **Discussion/Findings:**

We are recommending the following four new Vector Control classifications in the Health Care Services Agency that meet the progressive evolution in the level of work and expertise of the Alameda County Environmental Health Department Vector Unit. Existing staff will be reclassified to fill these new classifications.

The first classification is Job Code 5693SM, Vector Control Manager. Under direction of the Chief, Vector Control Services District, this position is responsible for direct supervision of the Supervising Vector Control Biologist and provides oversight and guidance for the programs administered by staff assigned to the County's Vector Control Service District. The second job classification is Job Code 5692SM, Supervising Vector Control Biologist. Under direction of the Vector Control Manager, this is the first supervisory level in the Vector Control Biologist series. Incumbents of the position supervise and direct the day-to-day work and operations of Senior Vector Control Biologist, Vector Control Biologist and support staff for conformity with established policy and procedures.

The third job classification is Job Code 5691NM, Senior Vector Control Biologist. Under direction of the Vector Control Biologist, this class provides lead responsibility for the Vector Control Programs and performs the duties of a Vector Control Biologist which include responsibilities in conducting vector control inspections, investigations, disease surveillance and control, and educational outreach. The fourth job classification is Job Code 5690NM, Vector Control Biologist, which is the journey-level classification, under oversight from the Senior Vector Control Biologist, conducts inspections, investigations, disease surveillance and control, and educational outreach.

The Alameda County Environmental Health Department is revered in the state as the leading expert in integrated pest management and vector biology. Many counties rely on the expertise of Alameda County vector biologist and field staff to advise and provide consultation in the various pest management programs that are currently drawing nationwide attention.

### Financing:

Funds are available in the 2014-2015 budget appropriation to pay the cost resulting from these actions.
