Recommendation:

That your Board adopt a Salary Ordinance amendment establishing a new job classification with salary administration criteria, in the Health Care Services Agency.

Discussion/Findings:

The Health Care Services Agency has requested the establishment of the new job class of Job Code 5075SM, Juvenile Justice Health Services Director. The incumbent of this position will plan, organize, direct and evaluate the operations of all health services programs for minors in the Alameda County juvenile justice system, including the Guidance Clinic, Public Health Nursing Transitional Program, Court Appointed Special Advocates (CASA) Program, and will serve as the primary liaison to the Juvenile Court and Probation Department for Juvenile Health Services operations.

The recommended salary is based on internal relationship with an existing Alameda County job classification with similar duties and responsibilities.

Funding:

Funds are available in the 2012 and 2013 budget appropriation to pay the cost resulting from this action.
