Recommendation:

Adopt a Salary Ordinance amendment amending Section 3-13.18 to add one position of Job Code 0283PA Labor Relations Analyst I, to receive additional compensation for performing higher level duties in the Human Resource Services Department.

Discussion/Findings:

We are amending Salary Ordinance Section 3-13.18 in the Human Resource Services Department, to add one additional position of Job Code 0283PA, Labor Relations Analyst I, when assigned overall Human Resource Service responsibilities for an operating Department to receive an additional five percent compensation. This assignment is beyond the normal duties performed by the Labor Relations Analyst I position.



SECTION II






