**Subject: Salary Ordinance Amendment** 

Dear Board Members:

## Recommendation:

That Your Board adopt a Salary Ordinance amendment (1) establishing two new job classifications, with salary administration criteria, in the Sheriff's Office, (2) an amendment to modify the salary range for two positions in the Treasurer-Tax Collector's Department and (3) an amendment to increase the salaries for employees represented by the Alameda County Management Employee Association (ACMEA) Probation Managers.

## **Discussion/Findings**:

The Sheriff's Office has requested the establishment of two new job classes. The first, Job Code 8724PA, Emergency Services Manager, will be responsible for the planning, organization, and direction of the internal and external emergency management and disaster preparedness program for Alameda County, and will assist cities within the County with emergency management and disaster preparedness programs. The salary recommendation is based on a survey of similar positions in the Bay Area.

The second job class is Job Code 6502PA, Youth and Family Services Manager. This position will have primary responsibility for planning and directing all clinical aspects of the Youth and Family Services Bureau, a division within the Alameda County Sheriff's Office, including the management and supervision of the activities of licensed professional, paraprofessional, technical and clerical staff, directly and through subordinate supervisory staff. The salary recommendation is based on relationships with subordinate staff.

In addition, the Treasurer-Tax Collector's Department has requested to modify the salary structure for Job Code 1539SM, Deferred Compensation and Personnel Manager and Job Code 0170PA, Chief Investment Officer Treasurer's Department; from step classes to deep class salary ranges. This will allow the Department more flexibility when appointing incumbents to the respective positions. However, there is no change to the salary amounts.

Lastly, the 2009-2015 Memorandum of Understanding with the Alameda County Management Employee Association, Probation Managers, provides for a salary increase for those employees related to the Deputy Probation Officer II benchmark classification in Teamsters, Local 856. Based on the agreement, the Teamster related classes are to receive a 2.76% increase, effective the first day of the second full pay period in January 2013.
