That your Board adopt a Salary Ordinance amendment establishing two new job classifications one in the Sheriff's Office and one in the General Services Agency.

Discussion/Findings:

The Sheriff's Office has requested the creation of the new job class of Job Code 8500, Sheriff's Estate Investigator, which is under the jurisdiction of the Sheriff-Public Administrator, to better align with the current organizational needs of the unit. This position is responsible for assisting in the technical work required to secure and safeguard property of decedent's estates.

We are also recommending establishing the new classification of Job Code 0184SM, Transportation Services Manager, in the General Services Agency. This position will be responsible for the overall administration, development and management of County-wide sustainable transportation programs. In addition, this position will be responsible for the County's transportation parking, motor vehicle and messenger operations.

Funding:

Cost resulting from this action will be included in the 2010-2011 budget appropriation.
