Subject: Memorandum of Understanding Amendment and Salary Ordinance Amendment

Dear Board Members:

Recommendation:

That your Board (1) adopt an Ordinance amending Appendix A of 2006-2015 Memorandum of Understanding between the Northern California Public Sector Region Local 1021, of the Service Employees International Union, Change to Win (CTW) and the County of Alameda, to increase the salaries for three job classifications in the General Services Agency, and (2) adopt a Salary Ordinance amendment to establishing a footnote for one job classification in the General Services Agency.

Discussion/Findings:

Your representatives and representatives of SEIU have agreed to the following salary increases for three job classifications in the General Services Agency: Procurement and Contracts Specialist I, we are recommending that the salary be increased by 14.24%; for the Procurement and Contracts Specialist II, we are recommending that the salary be increased by 8.52%; and for the Procurement and Contract Assistant, we are recommending that the salary be increased by 3.95%, to be comparable to that of the Specialist Clerk II position.

These increases are being recommended to address some serious retention issues over the last year to 18 months and to assist the Department with their retention needs.

Additionally, we are recommending that a footnote be established for the Procurement and Contracts Specialist II position, when assigned "lead" responsibilities over a Unit of other Procurement and Contract Specialist positions, to receive an additional five percent compensation.

Financing:

Funds are available in the 2013-2014 budget appropriation to pay the costs of these actions.

SECTION I

Article 3, of Ordinance Number of 0-2012-51 of the County of Alameda is hereby amended by the addition thereto of the following note, to be effective on the date shown.

3-11.23 Effective February 16, 2014, not to exceed three employees in Job Code 0173NM, Procurement & Contracts Specialist II, when assigned "lead" over a Unit of other Procurement & Contracts Specialist, shall receive an additional 5 percent compensation.
