Subject: Salary Ordinance Amendment

Dear Board Members:

Recommendation:

Adopt a first reading of a Salary Ordinance amendment (1) establishing two new Deferred Compensation job classifications, Deferred Compensation Specialist and Deferred Compensation Technician, to handle the increased amount of enrollments and Plan contributions based on the expansion of the County's Deferred Compensation Program in the Treasurer-Tax Collector's Office and (2) to increase the salary of the Assistant Director, Child and Youth Services, BHCS job classification for recruiting purposes.

Discussion/Findings:

We are recommending the following two Deferred Compensation classifications in the Treasurer-Tax Collector's Office: Job Code 1540PA, Deferred Compensation Specialist, and Job Code 1541NM, Deferred Compensation Technician, to handle the increased amount of enrollments and Plan contributions based on the expansion of the countywide defined contribution plans, the 457(b) Deferred Compensation Plan and the 401(a) Employee Retirement Plan. Creation of these two classifications will help the department in addressing their current staffing needs.

In addition, we are recommending that the salary of Job Code 5068SM, Assistant Director, Child and Youth Services, BHCS be increased by approximately 14% based on the departments realignment of their organizational structure to expand the scope of responsibilities, and span of control for this position to now include directorship of the Guidance Center as well as the Juvenile Justice Health Services. Also, increasing the salary prior to opening the recruitment will help the department to attract and retain a more qualified candidate.

Financing:

Funds are available in the 2014-2015 budget appropriation to pay the cost resulting from these actions.
