Subject: Salary Ordinance Amendment

Dear Board Members:

Recommendation:

That your Board adopt a Salary Ordinance amendment establishing two new job classifications – one in the Health Care Services Agency with salary administration criteria and one in the Sheriff's Office and adjusting two salary ranges.

Discussion/Findings:

We are recommending establishing the new job classification of Job Code 5098SM, Workforce Education and Training Manager, BHCS in the Health Care Services Agency. This position will oversee the administration of the Mental Health Services Act (MHSA) Workforce Education and Training Program for Behavioral Health Care Services (BHCS) including County and contractor-provided programs.

We are also recommending establishing the new job classification series of Job Codes 8516/8517, Forensic Computer Examiner I/II in the Sheriff's Office. This position is located in the Digital & Multimedia Evidence Unit of the Criminalist Laboratory and will assist with the examination of digital evidence associated with criminal activity, which has increased in recent years.

In addition, we are also making a slight adjustment in the salary range for two job classifications from a recently adopted amendment to accommodate the payroll system.

Financing:

Funds are available in the 2009-2010 budget appropriation to pay the costs of these actions.

Section 3-12.19 is hereby amended as follows:

3-12.19 - Persons occupying positions under Job Codes 0302PA (effective 3/7/10), 0310PA, 0313SM, 5044EM, 5047SM, 5049PA, 5065SM, 5067SM, 5071PA, 5077SM, 5079SM, 5080SM, 5086SM (effective 01/25/09), 5096SM (effective 09/20/09), 5098SM (effective 3/21/2010), 5643PA, 5791SM (effective 09/23/07), 5801SM (effective 11/15/09), 6141PA, 6186SM, 6494SM, or 6645SM and 6647SM (effective 01/25/09), may be compensated at any biweekly amount within the range of salaries shown for that classification, as determined by the Director of Health Care Services.
