Recommendation:

Adopt a Salary Ordinance amendment to establish the new job classification of Epidemiology Research Scientist, within the Division of Communicable Disease Control and Prevention (DCDCP) of the Public Health Department, with salary administration criteria.

Discussion/Findings:

We are recommending the new job classification of Job Code 5782SM, Epidemiology Research Scientist, located in the Division of Communicable Disease Control and Prevention (DCDCP) of the Public Health Department. This is a single-position class reporting to the Division of Disease Control and Prevention Director, and serves as a stand-alone scientific researcher. The incumbent works independently, designs, analyzes, and interprets scientific research related to communicable disease control and prevention for use in policy development, and designs evaluation studies to support the mission of the Public Health Department to ensure the optimal health and well-being of Alameda County residents. Additionally, the incumbent may supervise or oversee the work of professional, technical and support staff on a project or day-to-day basis.

Financing:

Appropriations for the establishment of the new job classification is included in the FY 2016-17 Approved Budget and there will be no increase in net County cost as a result of this action.
