SUBJECT:

BUDGET ADJUSTMENTS FOR ONE-TIME EMERGENCY IMMIGRANT

AND REFUGEE SERVICES CONTRACTS

RECOMMENDATION:

Authorize the Auditor-Controller to make the related budget adjustments to support Rapid Response hotline, "Know Your Rights" training and preemptive legal services and other related services for refugee and immigrant communities as approved by your Board on February 25 and March 11, 2025.

SUMMARY/DISCUSSION:

On February 25, 2025, (Item #27.1) your Board received a status report from the County Administrator that the Social Services Agency (SSA), Alameda County Health, and the Alameda County Probation Department had identified up to \$2.2 million that could potentially be reallocated within the Approved Budget on a one-time basis to support the Board's AC Together for All Ad Hoc Committee's emergency funding request for support services for refugee and immigrant communities in Alameda County.

On March 11, 2025, (Item #4) your Board approved in principle the allocation of emergency, one-time funding and delegated authority to the SSA Director to enter into the three one-year agreements for the Rapid Response hotline, "Know Your Rights" training, preemptive legal services and other related services to help ensure community access to reliable information regarding immigrant and refugee rights in an ever-changing landscape.

The contract scopes and budgets are being developed by SSA and will include quarterly updates to the Ad Hoc Committee and address contractor use of the County's existing language access services. The County Administrator's Office administers an existing Countywide contract for language access through which SSA will provide contractor access on an as-needed basis and monitor utilization to support the program objectives.

FINANCING:

One-time funding for these emergency support services to immigrant and refugee communities comes from one-time projected savings within the AC Health, Probation and Social Services Agency Approved Fiscal Year 2024-2025 Budget and will not increase net County costs.

VISION 2036:

Emergency support services to immigrant and refugee communities aligns with the County's 10X Goal pathways of **Health for All** and **Eliminate Poverty & Hunger** in support of our shared vision of a **Thriving & Resilient Population** and **Safe and Livable Communities.**
