**Subject: Salary Ordinance Amendment** 

Dear Board Members:

#### Recommendation:

That your Board adopt a Salary Ordinance amendment (1) adding a footnote in the Social Services Agency and (2) adjusting the salary for a job classification in the Health Care Services Agency, that includes salary administration criteria.

## Discussion/Findings:

The Social Services Agency, has requested that a footnote be established for one employee in Job Code 6752PA, Social Services Ombudsperson, to receive an additional five percent compensation, when serving as the Regional Ombudsman Coordinator as defined by the Welfare and Institutional Code Section 9700-9701. As the specialized knowledge necessary to provide oversight to the program, employees and the liaison work associated with the State, lie beyond the standard scope of duties for this position, this footnote will recognize the additional responsibilities.

Additionally, the Heath Care Services Agency has requested to adjust the salary for Job Code 5069SM, Director, Children & Youth Services, BHCS, to make the salary equivalent to the Adult System of Care Director, as the two positions are similar in the breath and scope of responsibilities within the Adult and Children's System of Care Divisions. This adjustment will change the salary from the current Step1-through Step-5 structure, and change to a "deep" class salary range.

Also, adjusting the salary will help the Department in their recruiting efforts of attracting and retaining the most qualified candidates and allow the Department more flexibility when appointing incumbents to the this position.

# Financing:

Funds are available in the 2013-2014 budget appropriation to pay the cost of these actions.
