Subject: Salary Ordinance Amendment

Dear Board Members:

## Recommendation:

Adopt a Salary Ordinance amendment to (1) establish the following six new job classifications aimed at providing distinct tasks and career opportunities for employees in the Information Technology Department: Technology Project Manager; Senior Technology Project Manager; Web Designer I/II/III; and County Webmaster, that includes salary administration criteria and (2) delete the provisions of Section 3-12.57, for one Senior Departmental Personnel Officer in the Health Care Services Agency, as the provisions are no longer needed.

## Discussion/Findings:

We are recommending the following six new job classifications in the Information Technology Department (ITD): Job Code 1851PA, Technology Project Manager and Job Code 1852PA, Senior Technology Project Manager, as a result of an analysis of the current class structure within ITD, which resulted in the need for a department specific classification series aimed at providing distinct task and opportunities for incumbents with specialized project management skills, specific to the area of Information Technology.

Also, Job Code 1854PA, Web Designer I; Job Code 1855PA, Web Designer II; Job Code 1856PA, Web Designer III; and Job Code 1857PA, County Webmaster are being created based on the lack of a classification series specifically directed at web design, development and maintenance, and to keep pace with the technology industry and to provide service to various county departments/agencies which utilize the intranet/internet throughout the course of daily business.

In addition, we are recommending deletion of Salary Ordinance Section 3-12.57, in the Health Care Services Agency, that currently provides for one position of Job Code 0465SM, Senior Departmental Personnel Officer, when assigned supervisory and management responsibility for the Human Resource Services of the Health Care Services Agency to receive and additional ten percent compensation. However, as the provisions of this footnote are include in the current job specification for the Senior Department Personnel Officer classification, this footnote is no longer needed.

#### Funding:

Funds are available in the 2015-2016 budget appropriation to pay the cost resulting from these actions.

#### **SECTION III**

Article 3, of Ordinance Number of 0-2015-54 of the County of Alameda, is hereby amended by the <u>deletion</u> therefrom of the following note, effective <u>May 8, 2016</u>.

3-12.57 Not to exceed one person occupying a position under Job Code 0465SM when assigned supervisory and management responsibility for the Human Resources functions of the Health Care Services Agency shall receive an additional 10 percent compensation.

This ordinance shall take effect immediately, and before the expiration of fifteen days after its passage, shall be published once with the names and of the members voting for and against the same in the Inter-City Express, a newspaper published in the said County of Alameda.
