Subject: Salary Ordinance Amendment

Dear Board Members:

Recommendation:

That your Board adopt a Salary Ordinance amendment (1) increasing the salaries for Unrepresented Non-Management Building & Construction Trades Council related classifications and (2) amending four footnotes: three in the Public Works Agency and one in the Human Resource Services Department.

Discussion/Findings:

The recent agreement with the Building & Construction Trades Council, contain a wage increase effective January 6, 2013, in the amounts ranging from 0.77% to 6.34% based on the job classification, which we are recommending be extended to the attached unrepresented non-management related job classifications. Additionally, there are also three footnotes which are being adjusted in the Public Works Agency, as a result of the settlement with the Building & Construction Trades Council agreement.

Also, we are amending Salary Ordinance Section 3-13.18 in the Human Resource Services Department, to add two additional positions of Job Code 0284PA, Labor Relations Analyst II, when assigned overall Human Resource Service responsibilities for an operating Department to receive an additional five percent compensation. This amendment expands the assignment of overall responsibilities for Human Resource Services to more than one Department.

Financing:

Funds are available in the 2013-2014 budget appropriation to pay the cost of these actions.

AN ORDINANCE AMENDING CERTAIN PROVISIONS OF THE 2013 - 2014 ALAMEDA COUNTY SALARY ORDINANCE

The Board of Supervisors of the County of Alameda ordains as follows:

SECTION I

Section 1-2.2 of Ordinance Number of 0-2014-7 of the County of Alameda, is hereby amended by the amendment thereof of the following Salaries, to be effective on the date shown.

Article 3, of Ordinance Number of 0-2014-7 of the County of Alameda, is hereby amended by the amendment thereof of the following notes:

- 3-15.1 Effective January 11, 2009 January 6, 2013, persons occupying positions under Job Code 9105D (Laborer) shall be entitled to additional compensation at the rate of \$0.46 \$0.48 per hour when assigned to duties of Hoseman-Oiler or Raker.
- 3-15.3 Effective January 11, 2009 January 6, 2013, any person occupying a position under Job Code 9616 (Bridge Tender) who formerly occupied the position of Operator Estuary Crossings and is x-scaled due to reclassification, will receive compensation at the rate of \$29.62 \$29.85 per hour.

3-15.8 - Effective January 11, 2009 January 6, 2013, not to exceed one person occupying a position under Job Code 9325 (Heavy Truck Driver), when assigned to operate the paint striping truck and maintain the painting apparatus on the truck, shall be entitled to additional compensation at the rate of \$1.52 \$1.53 per hour.

3-13.18 - Effective January 19, 2014, not to exceed one three employees in Job Code 0284PA, when assigned overall responsibilities for Human Resource Services for the Alameda County Fire Department for an Operating Department, shall be compensated an additional five percent of the base pay.

SECTION III

This ordinance shall take effect immediately, and before the expiration of fifteen days after its passage, shall be published with the names of the members voting for and against the same in the Inter-City Express, a newspaper published in the said County of Alameda.
