SUBJECT: AUTHORIZE AMENDMENT NO. 1 TO THE CONTRACT WITH DATASAFE,

INC. FOR MICROFILM RETENTION SERVICES; MASTER CONTRACT NO.

901511; PROCUREMENT CONTRACT NO. 14743

Dear Board Members:

RECOMMENDATION:

Authorize the Purchasing Agent to execute Amendment No. 1 (Master Contract No. 901511: Procurement No. 14743) with DataSafe, Inc. (Principal: Thomas Reis; Location: Newark) to provide additional microfilm retention services to the Alameda County Clerk-Recorder's Office, extending the current term of 7/1/17 - 6/30/20 by two years until 06/30/22, with no changes to the contract amount of \$75,000.

DISCUSSION/SUMMARY:

On April 25, 2017, your Board approved (Item No. 11) a three-year contract with DataSafe, Inc. to provide microfilm retention services. The contract allows for an extension of two additional years by mutual agreement.

The Clerk-Recorder's Office (CRO) is responsible for processing, preserving, and protecting official public records. DataSafe, Inc. has provided satisfactory service to the County and CRO with regards to the microfilm retention services. The CRO stores copies of official records on microfilm in two locations, one which is outside the Alameda County fault zones. The contract with DataSafe, Inc. provides the CRO with one of the locations for storage of over 11,500 units of microfilm in varying sizes stored in over 400 cubic feet of storage space.

SELECTION CRITERIA/PROCESS:

The CRO has determined that Alameda County does not currently have the resources to provide microfilm retention services in a secure location outside of the County's fault zones.

The CRO worked with the General Services Agency (GSA)—Procurement to develop a Request for Proposal (RFP) that was issued on November 28, 2016 and resulted in two responses. DataSafe, Inc. was the highest scoring bidder, met all of the requirements of the RFP, received favorable references, and is a certified Small Local Emerging Business (Certified Small: 11-00159; Expiration: 8/31/2021).

FINANCING:

Appropriations for this contract amendment are included in the CRO's Fiscal Year 2019-2020 Approved Budget and 2020-2021 MOE Budget, and will be requested in future budget years. No additional appropriations are required, and there will be no increase in net County cost.

VISION 2026 GOAL:

This microfilm retention services contract meets the 10X goal pathway of Accessible <u>Infrastructure</u> in support of our shared vision of a <u>Prosperous</u> and <u>Vibrant Economy</u>.
