**SUBJECT: ACCEPT THE CERTIFICATION OF THE RESULTS OF THE EXAMINATION  
OF THE PETITION TO RECALL ALAMEDA COUNTY DISTRICT  
ATTORNEY PAMELA PRICE AS SET FORTH IN THE CERTIFICATE OF  
SUFFICIENCY SUBMITTED HEREWITH**

Dear Board Members:

**RECOMMENDATION:**

Accept the certification of the results of the examination of the petition to recall Alameda County District Attorney Pamela Price as set forth in the Certificate of Sufficiency, and receive the Certificate of Sufficiency.

**DISCUSSION/SUMMARY:**

On August 15, 2023, the Registrar of Voters (“ROV”) received a Notice of Intention from proponents to recall Alameda County District Attorney Pamela Price from office. This was the first step in a process governed by both state and County of Alameda laws that govern the recall of a County of Alameda elected officer such as the District Attorney.

Between August 15 and September 27, 2023, the proponents of the recall effort took steps to issue required notices and perfect the required recall petition that could be used to gather signatures in support of the recall effort. On September 27, 2023, the ROV notified the proponents that the form of recall petition submitted on September 18, 2023, met the requirements of the California Elections Code (hereafter, “Elections Code”) and County of Alameda Charter (hereafter, “Charter”), Section 62. This notice allowed the proponents to begin circulating the petition and collecting signatures. It also triggered the 160-day deadline to submit signatures to the ROV. The deadline was March 5, 2024.

On March 4, 2024, the ROV received 123,374 signatures supporting the petition to recall Alameda County District Attorney Pamela Price. Between March 4 and April 15, 2024, the ROV verified the signatures to determine their validity, first using a random sampling, and then proceeding to a full manual count after the random sampling proved insufficient to constitute an accurate count. The ROV examined each signature as legally required. The proponents needed a minimum of 73,195 valid signatures. The number of valid signatures on the petition is 74,757. The total number of signatures disqualified is 48,617. Based on these numbers, the ROV determined that sufficient valid signatures were submitted for a recall election to be held. On April 15, 2024, the ROV certified the petition to be sufficient and notified the proponents by providing a copy of the Certificate of Sufficiency, pursuant to Elections Code Section 11224.

In compliance with the Ralph M. Brown Act and Elections Code Sections 11224 and 11227, the ROV hereby submits the Certificate of Sufficiency (see attached) to the Board of Supervisors for receipt at your meeting on April 30, 2024, the next regular meeting following April 15, 2024, for which the topic could be timely noticed for at least 72 hours on a Board meeting agenda. (See, Elections Code §§11224 and 11227.) The receipt of the Certificate of Sufficiency at your Board's meeting on April 30, 2024, will trigger an obligation on your part. Elections Code Section 11240 provides:

Within 14 days after the meeting at which the governing body received the certificate of sufficiency as specified in Section 11127, the governing body shall issue an order stating that an election shall be held pursuant to this article to determine whether or not the officer named in the petition shall be recalled.

Your Board will have until May 14, 2024, to issue the order calling for an election to determine whether District Attorney Pamela Price shall be recalled. Pursuant to Elections Code 11241, if your Board fails to issue the order by May 14, 2024, the ROV, within five days thereafter, shall set the date for holding the election.


### **FINANCING:**

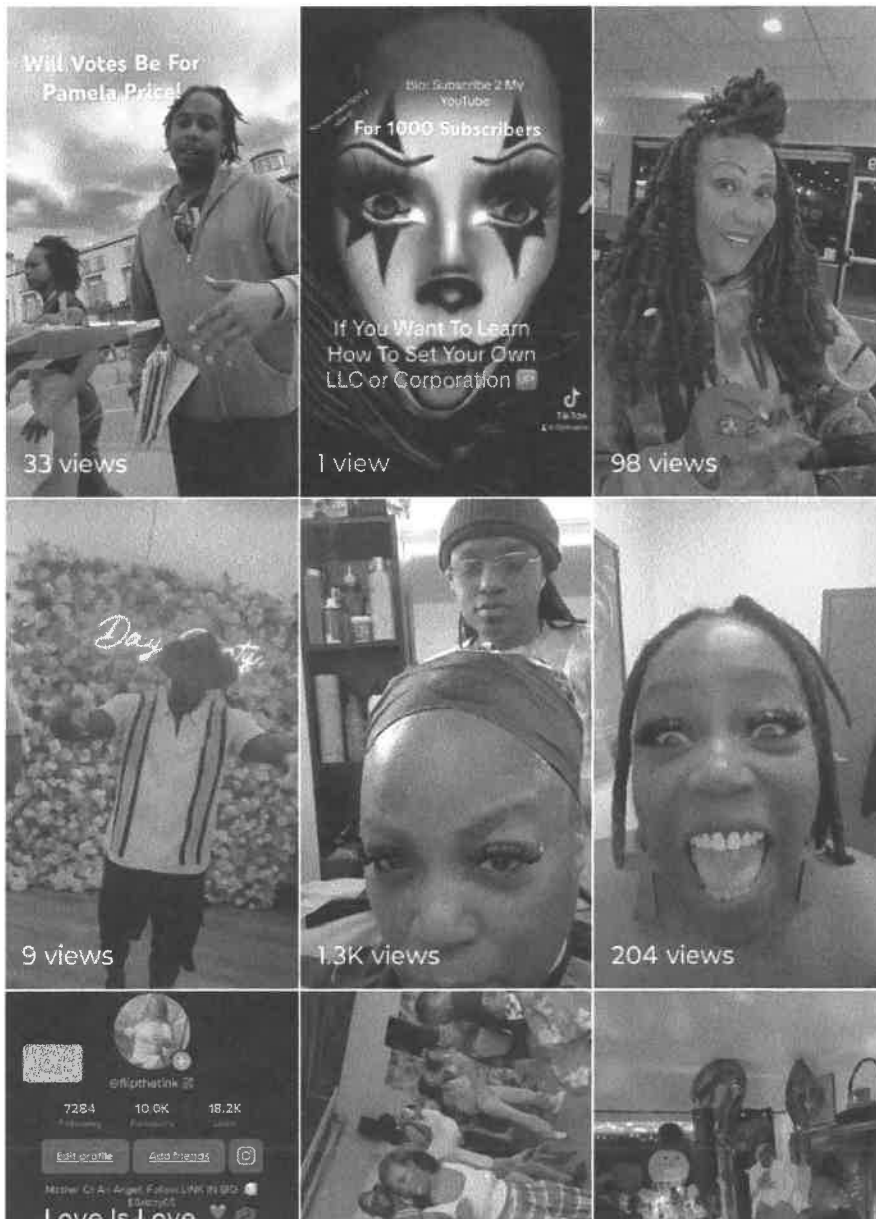

Re: Demand to Reject Certification of Recall Petition Results and Not Schedule Recall Election

Dear Supervisor:

On behalf of our client, District Attorney Pamela Price and the Protect the Win for Public Safety committee, we demand that the Board of Supervisors reject the Registrar of Voters' recent certification of the recall petition results and not schedule a recall election because the Registrar's review of the recall petitions violated Alameda County law.

The California Constitution provides that "[c]ounty charters adopted pursuant to this section shall supersede any existing charter and all laws inconsistent therewith." (Cal. Const., Art. XI, section 3(a).) Under the home rule doctrine, a county charter must supersede state law where "the county is legislating in its proper sphere." (San Bernardino County Board of Supervisors v. Monell (2023) 91 Cal.App.5th 1248, 1275.) This doctrine means that a county charter will control on matters "*concerning the operation of the county . . .*" (Curcini v. County of Alameda (2008) 164 Cal.App.4th 629, 640; emphasis in original.)

As you know, former County Charter section 62 outlines the legal requirements for the potential recall of County officers and differs from the provisions of state law about potential local recalls in numerous material ways. California law permits cities and counties to adopt charters regulating their election procedures which differ from state law. (See, e.g., Partnoy v. Shelley (S.D. Cal. 2003) 277 F.Supp.2d 1064, 1088 [holding that state Elections Code does not apply to recall elections where recall procedures are set forth in city or county charter].) Moreover, the California Elections Code explicitly provides that county charter provisions governing the recall of local officials supersede any conflicting provisions of state election law. (Cal. Elec. Code section 11000.) Based on this authority, there is no doubt that Charter section 62 is valid and necessarily governs potential recalls of County officials.

Though the voters repealed this Charter provision at the March 2024 election, the repeal did not take effect until early April, after the results of the election were officially certified and

accepted by the Secretary of State's office pursuant to California Government Code section 34459. The proponents launched the effort to recall District Attorney Price in the fall of 2023, gathered signatures between the fall of 2023 and March 2024, and submitted the signed petitions to the County on March 4, 2024 – all actions which took place long before the repeal of section 62. There is therefore no dispute that Charter section 62 governs the Registrar's review of the signatures on this recall petition.

Despite the unequivocal application of section 62 to the signature verification process, the Registrar's Office blatantly ignored two clear legal requirements. First, section 62 explicitly requires the Registrar's Office to review the signatures within 10 days:

"Within ten days from the filing of such petition the County Clerk shall, from the records of registration, determine whether or not said petition is signed by the requisite number of qualified electors . . . "

Despite this mandate, the Registrar did not complete the verification process by March 14 (10 days from the day when the petitions were filed) – and in fact did not do so until April 15, weeks beyond the 10-day mandatory review period. This fact alone makes the results of the signature review process illegal and mandates that the Board reject the Registrar's certification of the results and not schedule the election.

We acknowledge that 10 days is a short amount of time to verify whether 123,000 signatures actually came from validly-registered Alameda County voters. We also acknowledge that state law gives local registrars more time to review local recall petitions (30 working days, pursuant to Elections Code section 11224(a)). However, the Registrar can not rely on state law in the face of the clear edict of the County Charter.

Moreover, section 62 recognizes that 10 days is a short amount of time to review recall petitions by explicitly requiring the Board of Supervisors to appropriate sufficient funds to the Registrar's office to hire enough staff to complete the review within this time period:

"If required by the County Clerk, the Board of Supervisors shall authorize him to employ, and shall provide for the compensation of persons necessary in the examination of said petition and supplementing petition, in addition to the persons regularly employed by him in his office."

The Charter's procedural requirements could not be clearer. The Registrar had a legal duty to review the signatures in 10 days and to ask the Supervisors for additional funding if necessary. Instead, the Registrar ignored its mandate under the Charter, so the results of the verification process can not be accepted.

We also acknowledge that the Registrar's Office completed a "random sample" of 3 percent of the signatures within the 10-day timeframe. Under state law, local registrars may conduct a random sample of signatures in lieu of reviewing every signature, and must thereafter conduct a full count of all signatures if the results of the random sample are inconclusive. We do not have an opinion on whether the Registrar's office was authorized to conduct a random sample or whether it was authorized to conduct a full count when the results of the random sample were inconclusive. The law is clear, however, that whatever process the Registrar follows to verify the signatures, it was legally required to comply with the Charter and complete the verification by March 15.

The Registrar's Office disregarded another clear provision in the Charter, which is an independent reason for the Board to reject the results and not schedule the election. The Charter clearly states that only county residents are authorized to gather signatures on a recall petition:

"To each separate paper of such petition shall be attached an affidavit made by a qualified elector of the County (or particular subdivision of the County as the case may be), stating that the affiant circulated that particular paper and saw written the signatures appended thereto . . ."

As you know, we have raised this legal issue with the County in the past, and County Counsel has opined that the provision is not enforceable based on the Supreme Court's decision in Buckley v. American Constitutional Law Foundation (1999) 552 U.S. 182. We disagree that Buckley is controlling over this question because it only involved gathering signatures on initiatives concerning public policy issues, and we believe that the County is justified in limiting circulators to County residents when the goal is overturning the results of a bona fide election for a County official.

More notably, regardless of how a court may ultimately rule on this open legal question, the California Constitution clearly prohibits the County from ignoring a County law until and unless a court rules that the law is enforceable. (Cal. Const., Art. III, section 3.5.) We raised this Constitutional requirement with the County in December 2023, so the County has had ample time to ask a court to opine on this question. Because it did not, and because no court has ever ruled on the question of whether a local jurisdiction may limit the circulators of a recall petition to residents of the jurisdiction, the Registrar had a legal obligation to reject any signatures collected by non-County residents. (We have asked the Registrar how many circulators are not County residents and how many signatures are on those petitions, but to date it has refused to provide us with this information.) Given that the proponents gathered only about 1,500 more signatures than needed, we have every reason to believe that invalidating signatures obtained by non-County residents would reduce the number of signatures far below the required number. The failure of the Registrar's Office to do so is an independent reason for the Board to reject the results and not schedule the election.

Recalling a County official who was elected in a bona fide, democratic election is a drastic act, especially when the recall effort is begun so soon after voters have elected the person to office. The review of recall petitions therefore demands strict compliance with all legal and procedural requirements set out in the Charter, state Elections Code, and other binding legal precedent. Here, the Registrar blatantly ignored at least two clear provisions of County law when verifying the signatures on this recall petition, errors and omissions which serve to invalidate the results of that review. We therefore urge the Board to intercede in the process, and not let this illegal recall move forward.

We look forward to discussing these legal issues with you in more detail at your meeting on April 30<sup>th</sup>.
