Subject: Salary Ordinance Amendment

Dear Board Members:

Recommendation:

That your Board adopt a Salary Ordinance amendment establishing a new job classification, with salary administration criteria, in the Alameda County Employee's Retirement Association (ACERA) and to amend the salary for a job classification in the Sheriff's Office.

Discussion/Findings:

The Alameda County Employee's Retirement Association has requested the establishment of a new job classification, Job Code 1349SM, Senior Investment Officer, ACERA. The incumbent of the position will be responsible for conducting complex research and analysis related to the retirement's fund investment, for performing real estate program oversight and assisting with the administration of the investment programs. The salary recommendation is based on internal salary relationships to other senior managers at ACERA.

Additionally, we are recommending increasing the top step salary for Job Code 6502PA, Youth and Family Services Manager by 3.88%. In an earlier action, we inadvertently submitted an incorrect salary for the top step. This amendment will address this issue.

Funding:

Funds are available in the 2012 and 2013 budget appropriation to pay the cost resulting from this action.
