Subject: Salary Ordinance Amendment

Dear Board Members:

Recommendation:

That your Board adopt a Salary Ordinance amendment establishing a new job class in the Public Works Agency with salary administration criteria, and amending a footnote in the General Services Agency, and adding a footnote in the Registrar of Voters.

Discussion/Findings:

We are recommending the new job class of Public Art Program Coordinator, Item #2090PA in the Public Works Agency. The position is located in the Public Works Agency, but provides countywide services in support of the Alameda County Arts Commission (ACAC)'s directive to develop and implement public arts projects for county capital improvement projects involving the design and integration of artwork into the construction of public sites and buildings.

We are also recommending a footnote for one position of Information Systems Technician II, when assigned the additional responsibilities of supervising and overseeing the Vote Count Room election processing activities, and amending a footnote in the General Services Agency to compensate an employee for additional supervisory responsibilities.

Financing:

Funds are available in the 2008-2009 budget appropriation to pay the costs of these actions.

AN ORDINANCE AMENDING
CERTAIN PROVISIONS OF THE 2008 - 2009
ALAMEDA COUNTY SALARY ORDINANCE

The Board of Supervisors of the County of Alameda ordains as follows:

SECTION I

Article 3 of Ordinance Number 0-2008-48 of the County of Alameda is hereby amended by the addition thereto of the following Job Code Number, Title, and Salary to be effective May 17, 2009.

SECTION II

Article 3 of Ordinance Number 0-2008-48 of the County of Alameda is hereby amended by the amendment thereto of the following notes to be effective May 17, 2009.

3-15.4 Add "and job code 2090PA"

3-11.22 Add "and job code 7423SM"

SECTION III

Article 3 of Ordinance Number 0-2008-48 of the County of Alameda is hereby amended by the addition thereto of the following note to be effective May 17, 2009.

3-16.5 Not to exceed one person employed under Job Code 0411, Information Systems Technician II, when assigned the additional responsibilities of supervising and overseeing the Vote Count Room election processing activities, shall be compensated an additional ten percent (10%).

SECTION IV

This ordinance shall take effect immediately, and before the expiration of fifteen days after its passage, shall be published once with the names of the members voting for and against the same in the Inter-City Express, a newspaper published in the said County of Alameda.
