NON-MANAGEMENT CLASSES RELATED TO SEIU, LOCAL 1021 AND 2) AMEND SUBSECTIONS 3-12.19

AND 3-17.36

Dear Board Members:

RECOMMENDATION:

Adopt Salary Ordinance amendments to:

- i. increase the salaries for 15 Unrepresented Non-Management classifications related to the Northern California Public Sector Region Local 1021 of the Service Employees International Union ("SEIU, Local 1021") classifications, effective June 28, 2020:
- ii. amend the salary administration criteria referenced in Article 3, subsections 3-12.19 and 3-17.36 to include the classifications of Ancillary Support Worker, HCSA (JC #5021NM) located in the Health Care Services Agency ("HCSA") and Regional Training Center Instructor SAN (JC #8549N) located in the Sheriff's Department, respectively, effective June 28, 2020.

DISCUSSION/SUMMARY:

We recommend increasing the salaries for the following 15 Unrepresented Non-Management job classifications related to SEIU, Local 1021: 1) Ancillary Support Worker, Health Care Services Agency, Job Code ("JC") #5021NM, 2) Behavioral Clinician II SAN (JC #6510N), 3) Court Appointed Special Advocates (CASA) Volunteer Program Assistant (JC #6186NM), 4) Eligibility Technician Intermittent (JC #1477N), 5) Institutional Helper SAN (JC #6696N), 6) Marriage and Family Therapist II N (JC #6497N), 7) Medical Social Worker II SAN (JC #6415N), 8) Psychiatric Mental Health Nurse Practitioner (JC #5384NM), 9) Regional Training Center Instructor EVOC (Emergency Vehicle Operations) SAN (JC #8550N), 10) Regional Training Center Lead Instructor SAN (JC #8551N), 11) Regional Training Center Instructor SAN (JC #8549N), 12) Sheriff's Service Cadet SAN (Services As Needed) (JC #8751N), 13) Social Welfare Intern SAN (Job Code #6704N), 14) Special Assistant to Volunteer Program Coordinator (JC #6181NM), and 15) Training Center Customer Service Representative, Training & Education Center (JC #0480NM) to receive the same three and one-half percent (3.5%) salary increase effective June 28, 2020, as granted to SEIU, Local 1021 represented classifications. In addition, staff recommends amending Article 3, Section 3-12, subsection 3-12.19 for one (1) HCSA classification (Ancillary Support Worker, HCSA (JC #5021NM)); and Section 3-17, subsection 3-17.36 for one (1) Sheriff's Department classification (Regional Training Center Instructor SAN (JC #8549N)) of the Salary Ordinance to include salary administration criteria for these two (2) classifications, effective June 28, 2020.

FINANCING:

Funds are available in the 2019-2020 Approved Budget and will be included in future years' requested budgets to cover the costs resulting from these actions.

AN ORDINANCE AMENDING CERTAIN PROVISIONS OF THE 2019 – 2020 COUNTY OF ALAMEDA SALARY ORDINANCE

The Board of Supervisors of the County of Alameda ordains as follows:

SECTION I

Article 1, Section 1-1, Subsection 1-1.1 of the County of Alameda Salary Ordinance is hereby amended to specify the following salary rates, to be effective on June 28, 2020:

3-17.36 - The employee occupying the position under Job Codes 1871SM; 6072EM; 6500SM-; 6502PA-; 8549N; 8724PA-; 8751N; 8756PA; 8850PA; and 8860PA may be compensated at any biweekly amount in the salary range for that class as determined by the Department Head. (BOS approved 5/24/16 Job Codes 8756PA and 8751N effective 6/5/16) (BOS approved 8/2/16 Job Code 1871SM effective 7/31/16), and Job Code 6072EM effective 1/29/17 (BOS approved 1/24/17).

SECTION III

This ordinance shall take effect immediately, and before the expiration of fifteen days after its passage, shall be published once with the names of the members voting for and against it in the Inter-City Express, a newspaper published in the County of Alameda.
