**WHEREAS**, Preventable injuries are the #1 killer of children in the United States, with millions more injured in ways that can affect them for a lifetime; and

**WHEREAS**, All children deserve the chance to grow up safe from life-altering injuries from vehicle collisions, drownings, fires or falls that could have been prevented; and

**WHEREAS**, Nearly 340,356, or 19.5% of Alameda County residents are under the age of 18; and

**WHEREAS**, Alameda County Emergency Medical Services is the Lead Agency for **Safe Kids Alameda County**, a coalition comprised of governmental programs, health care, public safety, and community-based organizations; and

**WHEREAS**, on July 19, 2025, Safe Kids Alameda County is holding their 11<sup>th</sup> annual **Safe Kids Day**, providing injury prevention education and distributing safety equipment to the public at no cost; and

**WHEREAS**, **Safe Kids Day 2025**, is designed to celebrate kids and provide resources to assist Alameda County parents and caregivers in taking action to protect their children on the roadway, at home, and while at play; and

**WHEREAS**, **Safe Kids Day 2025**, is made possible with generous support from AEG Community Foundation, Oakland Arena, Oakland Alameda County Coliseum, AAA Northern California, Sutter Health Eden Medical Center, Falck, Alameda Health System Highland Hospital, Hively, and the California Office of Traffic Safety; and

**WHEREAS**, the professionals and organizations who comprise **Safe Kids Alameda County** deserve to be recognized and honored for their work as in 2024, they provided outreach across all unintentional injury areas to 278,635 youth and caregivers, or 16.89% of Alameda County; provided training to 2,704 professionals; and distributed 2,503 pieces of safety equipment at no cost to residents; and

**NOW, THEREFORE**, this Board of Supervisors, County of Alameda, State of California, does hereby proclaim **July 19, 2025 as Safe Kids Day** in Alameda County.

**WHEREAS**, The Center for Independent Living (CIL), established over 50 years ago, is the first independent living center in the country, and provides advocacy, programs and services in support of the rights, independence and inclusion of people with diverse disabilities.

**THEREFORE**, this Board of Supervisors, Alameda County, State of California, does hereby proclaim July 26th, 2025, as the 35th anniversary of the Americans with Disabilities Act. We commend and celebrate CIL's commitment to building a more equitable society that values the contributions of individuals with disabilities and the legacy of the ADA's impact on our community.
