That your Board (1) adopt a Salary Ordinance amendment increasing salaries for two job classifications in the Health Care Services Agency, (2) establish a new job classification in the Human Resource Services Department, with salary administration criteria, and (3) adopt one sideletter of agreement.

### Discussion/Findings:

We are recommending increasing the salaries for Job Code 5141MA, Physician IV and Job Code 5143MA, Physician V, in the Health Care Services Agency, to address a compaction, recruitment and retention problem resulting from the December 12, 2010 salary increase for the Physician III job classification, based on MOU provisions for employees represented by the Union of American Physicians and Dentists.

The sideletter of agreement between the Alameda County Management Employees Association and the County confirms that future wage increases for the Physician IV and Physician V classifications, shall be the same as those granted to the Physician III classification.

Additionally, we are recommending the new job classification of Job Code 0293SM, Personnel Services Manager, in the Human Resource Services Department. Incumbents of the position have overall responsibility for managing the day-today functions in the Personnel Services Division that include recruitment, selection, classification, compensation, and certification through the exercise of program management and direct supervision over the work of professional, technical and support staff and are also assigned the more difficult projects with important technical and public relations aspects.

### Financing:

Funds are available in the 2012-2013 budget appropriation to pay the costs resulting from these actions.
