Subject: Salary Ordinance Amendment

SECOND READING

Dear Board Members:

Recommendation:

That your Board adopt a Salary Ordinance Amendment establishing one new class in the Sheriff's Office with salary administration criteria and adding a footnote in the Probation Department.

Discussion/Findings:

We are recommending one new job class of Chief Forensic Pathologist 5149MA, in the Sheriff's Office with salary administration criteria. In addition to conducting autopsies and performing off-site functions as required, the incumbent in this position would be responsible for overall caseload management for the Coroner's Bureau and the selection of contract pathologists as necessary.

Additionally, your representatives and representatives of the Alameda County Management Employees Association, Probation Managers Unit (075) have reached agreement on additional footnote compensation for the Institutional Supervisor II classification working lower-level additional shifts in the Juvenile Justice Facility on a voluntary basis.

Financing:

Funds are available in the 2007-2008 budget appropriation to pay the costs of this action.

AN ORDINANCE AMENDING
CERTAIN PROVISIONS OF THE 2007-2008
ALAMEDA COUNTY SALARY ORDINANCE

The Board of Supervisors of the County of Alameda ordains as follows:

SECTION I

Section 1-2.2 of Ordinance Number 0-2007-52 of the County of Alameda is hereby amended by the addition thereto of the following Job Code Number, Title and Salary effective September 7, 2008:

SECTION II

Article 3 of Ordinance Number 0-2007-52 of the County of Alameda is hereby amended by the amendment thereof of the following note.

Subsection 3-17.37 is hereby amended to read as follows:

The persons occupying positions under Job Code 8560PA or 5149MA may be compensated at any salary within the range for the respective class at the discretion of the Sheriff.

SECTION III

Article 3 of Ordinance Number 0-2007-52 of the County of Alameda is hereby amended by the addition thereof of the following note.

Subsection 3-14.22 Effective July 13, 2008, an employee who is regularly assigned as an Institutional Supervisor II, job code 6225, who is assigned to work an additional full 8 hour shift, performing the job duties of job code 6217 shall be compensated at step five at the time and a half rate (1.5) for job code 6217. This compensation shall only be provided when the Superintendent, Juvenile Hall and/or Senior Institutional Supervisor has pre-approved the assignment of job code 6225 to work in the capacity of job code 6217.

SECTION IV

This Ordinance shall take effect immediately, and before the expiration of fifteen days after its passage, shall be published once with the names of the members voting for and against the same in the Inter-City Express, a newspaper published in the said County of Alameda.
