**Subject: Salary Ordinance Amendment**

Dear Board Members:

**SECOND READING**

**Recommendation:**

That your Board adopt a Salary Ordinance amendment adding two footnotes; one in the Health Care Services Agency and one in the Community Development Agency.

**Discussion/Findings:**

We are recommending a footnote compensation for one position of Medical Social Worker II, in the Public Health Department, when assigned lead responsibilities over the Asthma Start program staff and complex programmatic day-to-day activities, which includes but not limited to the oversight of work, guidance and review of cases to other Medical Social Workers, Community Outreach Workers and program support staff on a daily basis.

In addition, we are recommending additional footnote compensation for one position of Agricultural Biologist when assigned and performing duties related to the canine inspection of agricultural shipments and for the care and feeding of canine.

**Financing:**

Funds are available in the 2010-2011 budget appropriation to pay the costs of these actions.



AN ORDINANCE AMENDING  
CERTAIN PROVISIONS OF THE 2010 - 2011  
ALAMEDA COUNTY SALARY ORDINANCE

The Board of Supervisors of the County of Alameda ordains as follows:

**SECTION I**

**Article 3** of Ordinance Number 0-2009-51 is hereby amended by the addition thereto of the following notes.

Subsection 3-12.77 Effective September 19, 2010, not to exceed one person occupying the position under Job Code #6415, when assigned "lead" responsibilities over one or more employees in the Alameda County Asthma Start program, shall receive an additional five percent compensation.

Subsection 3-21.85 Effective September 19, 2010, not to exceed one position under Job Code #8215, in the Agricultural /Weights and Measures Department, when assigned and performing duties related to the canine inspection of agricultural shipments, shall receive an additional five percent compensation and in addition, shall receive an additional \$30.00 per bi-weekly pay period for the care and feeding of canine.

**SECTION II**

This ordinance shall take effect immediately, and before the expiration of fifteen days after its passage, shall be published once with the names of the members voting for and against the same in the Inter-City Express, a newspaper published in the said County of Alameda.
