Subject: Salary Ordinance Amendment

Dear Board Members:

Recommendation:

Adopt the following Salary Ordinance amendments:

- A. Establish the classification of Human Resource Division Manager in the Human Resource Services Department that includes salary administration criteria; and
- B. Establish the classification of Psychiatric Mental Health Nurse Practitioner in the Health Care Services Agency Behavioral Health Care Division.

Discussion/Findings:

We recommend establishing the new job classification of Job Code 0294SM, Human Resource Division Manager, as part of a departmental reorganizational plan to align senior-level leadership within Human Resource Services. This position, under the direction of the Director of Human Resource Services, develops, plans, organizes, administers, and directs the activities of a centralized division that has countywide impact and responsibility, and will be assigned to the Administrative Services, Employee Benefits, Personnel Services, and Training and Education divisions.

Also, we recommend the new job classification of Job Code 5384SM, Psychiatric Mental Health Nurse Practitioner located in the Health Care Services Agency Behavioral Health Care Services Division. This position, under the clinical and administrative supervision of a Medical Director is responsible for providing professional psychiatric evaluation, nursing assessment and diagnostic services, prescribing medication, providing technical assistance, assisting in policy and protocol development, quality assurance and implementation of program standards. Additionally, the position is distinguished from the physician series in that incumbents must practice with a physician supervisor and within the parameters of a Scope of Practice and Standardized Procedure Agreement.

Financing:

Funds are available in the 2017-2018 budget appropriation to pay the cost resulting from these actions.

AN ORDINANCE AMENDING CERTAIN PROVISIONS OF THE 2016 - 2017 ALAMEDA COUNTY SALARY ORDINANCE

The Board of Supervisors of the County of Alameda ordains as follows:

SECTION I

3-13.3 Persons employed under Job Codes 0261SM, 0262SM, 0263CA, 0265CA, 0266CA, 0267PA, 0268CA, 0269CA, 0276CA (effective 10/12/14), 0277SM, 0279CA, 0280CA, 0281SM, 0282CA, 0283CA, 0284PA, 0285SM, 0286EM, 0287SM, 0289SM, 0290EM, 0291PA, 0292SM (effective 4/4/10), 0293SM (effective 8/5/12), 0463SM (effective 6/9/13), 0464CA (effective 4/9/17), 0466PA, 0467CA, 0468SM, 0471SM, 0473SM, 0474PA, 0477PA, 0479PA, 0482PA, and 0483PA and 0294SM (effective 9/8/17), may be compensated at any biweekly amount within the range of salaries shown for that classification as determined by the Department Head.
