Subject: Salary Ordinance Amendment

Dear Board Members:

Recommendation:



That your Board adopt a Salary Ordinance amendment adding two new job classifications in the Health Care Services Agency and one new job classification in the Sheriff's Office.

Discussion/Findings:

We are recommending the new job class of Critical Care Manager, BHCS in the Health Care Services Agency. The position is responsible for monitoring and coordinating acute and sub-acute system resources and authorizing services for adults or adolescents on involuntary psychiatric holds or in need of acute psychiatric care.

We are also recommending the new job class of Financial Services Director, Health Care Services Agency. Responsibilities include overseeing all aspects of the Agency's financial operations which include: accounting, contracts administration, claims, and revenue generating operations and related administration functions of the Health Care Services Agency.

Lastly, we are recommending the new job class of Youth and Family Services Intern, in the Sheriff's Office. Positions in this class are unique to the Youth and Family Services Bureau of the Alameda County Sheriff's Office. Incumbents are participants in a part-time or short-term (usually not exceeding twelve months) internship program conducted in accordance with the California Board of Behavioral Science regulations governing the training of Marriage and Family Therapist (MFT) Interns. Board regulations require that individuals participating in this program be registered MFT Interns with the California Board of Behavioral Science Examiners, or qualify as MFT Trainees who have recently completed or are currently enrolled in a Master's Degree program in a field approved for MFT Licensure by the Board.

SECTION I
