**Subject: Salary Ordinance Amendment** 

**Dear Board Members:** 

#### Recommendation:

- A. Establish the New Job Classification of Procurement Administrator, in the General Services Agency (GSA) that includes salary administration Criteria; and
- B. Delete the provisions of Salary Ordinance Section 3-11.14 in the General Services Agency

### **Discussion/Findings:**

We are recommending the new job classification of Job Code 0185SM, Procurement Administrator in the General Services Agency. This single position class will report to the Chief Deputy of Administration, GSA and will serve as a director over the Manager, Purchasing Division. The creation of this new position will enable GSA to meet the needs of its customers and achieve strategic objectives of the Agency for all of the County's procurement needs.

In addition, we are recommending the deletion of Salary Ordinance Section 3-11.14, in the General Services Agency which provides an additional ten percent compensation for the Deputy Director, General Services Agency when assigned responsibility for county-wide Real Estate Services, as these duties have been incorporated into the revised job specification of the Deputy Director, General Services Agency job classification.

### Financing:

Funds are available in the 2016-2017 budget appropriation to pay the cost resulting from these actions.
