**SUBJECT: Public Auction Sale of Tax Defaulted Property**

**RECOMMENDATION:**

Adopt the attached resolution authorizing the Treasurer-Tax Collector to sell at online public auction from March 17-20, 2023, and to re-offer from May 19-22, 2023, for the stated minimum price, the tax defaulted property which is subject to the power of sale and described on the attached schedule.

**DISCUSSION/SUMMARY:**

In accordance with Chapter 7 of Part 6 of Division 1 of the California Revenue and Taxation Code, five years or more after a property has become tax defaulted, the Tax Collector may sell all or any portion of the tax defaulted property that has not been redeemed.

Your approval to sell (at public auction or by public internet auction), for the stated minimum price, the tax defaulted property that is subject to the power of sale and described on the attached schedule, in accordance with Chapter 7 of Part 6 of Division 1 of the California Revenue and Taxation Code, is requested.

In the event that any parcel does not sell after the initial offering, I respectfully request your approval to re-offer the unsold parcel(s) at the end of the auction at a reduced minimum price pursuant to Revenue and Taxation Code section 3698.5(c), at a new sale within 90 days of the original sale date pursuant to California Revenue and Taxation Code section 3692(e). Any new parties of interest shall be notified in accordance with Revenue and Taxation Code section 3701. If excess proceeds result from the sale, notice will be given to parties of interest, pursuant to California Revenue and Taxation Code section 4676.

The Treasurer-Tax Collector's Office has secured a Standard Agreement Contract with the vendor, Bid4Assets, Inc., for the period of January 1, 2022, through December 31, 2023, under Master Contract Number C-901683 and Procurement Contract Number C-17661, on the Board agenda of September 28, 2021.

The Authorization and Report of Sales list, detailing all properties that will be subject to the March 17 through March 20, 2023, auction and the May 19 through May 22, 2023, re-offer is attached for your information.

**FINANCING:**


Funds are available in the departmental budget for FY 2022-2023, with no increase in net county cost.

**RESOLUTION FOR EXECUTION OF THE SALE OF TAX DEFAULTED LAND IN ACCORDANCE WITH DIVISION 1, PART 6, CHAPTER 7 OF THE CALIFORNIA REVENUE AND TAXATION CODE.**

WHEREAS, pursuant to Chapter 7 of Part 6 of Division 1 of the California Revenue and Taxation Code, five years or more after a property has become tax defaulted, the County Tax Collector may sell all or any portion of the tax defaulted property that has not been redeemed; and

WHEREAS, the Treasurer-Tax Collector has submitted the attached Authorization and Report of Sales list, detailing all properties that will be subject to a proposed March 17 through March 20, 2023 auction and the May 19 through May 22, 2023 re-offer; and

WHEREAS, the Treasurer-Tax Collector's Office has secured a Standard Agreement Contract with the vendor, Bid4Assets, Inc., for the period of January 1, 2022, through December 31, 2023, under Master Contract Number C-901683 and Procurement Contract Number C-17661, on the Board agenda of September 28, 2021, for the purposes of the sale of tax defaulted property; and

WHEREAS, the Treasurer-Tax Collector requests approval to sell (at public auction or by public internet auction), for the stated minimum price, the tax defaulted property that is subject to the power of sale and described on the attached schedule, in accordance with Chapter 7 of Part 6 of Division 1 of the California Revenue and Taxation Code; and

WHEREAS, in the event that any parcel does not sell after the initial offering, the Treasurer-Tax Collector respectfully requests approval to re-offer the unsold parcel(s) at the end of the auction at a reduced minimum price, pursuant to California Revenue and Taxation Code section 3698.5(c), at a new sale within 90 days of the original sale date; pursuant to California Revenue and Taxation Code section 3692(e); and

WHEREAS, any new parties of interest shall be notified in accordance with Revenue and Taxation Code section 3701; and

WHEREAS, if excess proceeds result from the sale, notice will be given to parties of interests, pursuant to California Revenue and Taxation Code section 4676.

**NOW, THEREFORE, BE IT RESOLVED**, that approval for sale and re-offer of tax defaulted land as requested by the Treasurer-Tax Collector and described in Division 1, Part 6, Chapter 7, of the California Revenue and Taxation Code is hereby granted.


**BE IT FURTHER RESOLVED**, that execution of public sale of tax defaulted land shall proceed for at least the minimum price set forth as the minimum bid.


