#### NOTICE OF PUBLIC HEARING REGARDING ISSUANCE OF MULTIFAMILY HOUSING REVENUE BONDS FOR ALPINE APARTMENTS

NOTICE IS HEREBY GIVEN that, at 11:00 a.m., or as soon thereafter as the matter can be heard, on Tuesday, April 22, 2008, at the County Administration Building, 1221 Oak Street, Oakland, in the 5th Floor Board Chambers, Oakland, California, the Board of Supervisors of the County of Alameda (the "County") will conduct a public hearing as required by Section 147(f) of the Internal Revenue Code of 1986, at which it will hear and consider information concerning a proposed plan of financing providing for the issuance by the California Statewide Communities Development Authority of multifamily housing revenue bonds in one or more series issued from time to time, including bonds issued to refund such revenue bonds in one or more series from time to time, and at no time to exceed \$10,000,000 in outstanding aggregate principal amount, to finance the acquisition and rehabilitation of a 57-unit multifamily rental housing project, located at 1282-1286 Mattox Road, Hayward, Alameda County, California, and generally known as Alpine Apartments (the "Project"). The Project will be owned and operated by Levy Affiliated Holdings, LLC or related entities.

Those wishing to comment on the proposed financing and the nature and location of the Project may either appear in person at the public hearing or submit written comments, which must be received by the County prior to the hearing.
