


TELECONFERENCING GUIDELINES FOR PUBLIC PARTICIPATION IN THE COUNTY OF ALAMEDA JOINT BOS AD HOC COMMITTEE ON REPARATIONS & REPARATIONS COMMISSION

Members of the public may appear in-person and participate in meetings of the Ad hoc Committee on Reparations and or Reparations Commission. Alternatively, members of the public may choose to view meetings and participate remotely through teleconferencing. **Members who choose remote participation may participate in the meetings and address the Board during the meetings in the following ways.**

Public Comment via Teleconference

Members of the public may address the Committee and or Commission regarding matters on the agenda before or during consideration of an item, **and** during the Public Input portion of the meeting for matters not on the agenda. Matters not on the agenda must be within the Board's subject matter jurisdiction.

 - If you decide not to speak, you may hang up and dial back into the meeting or simply notify the Clerk you do not wish to speak when you are unmuted and asked to speak.
