Vision 2026 Town Halls

Melanie Moore, Director, ALL IN, reported on the Vision 2026 Town Hall Meetings.

Vision 2026 is Alameda County's comprehensive effort to set a course for the next decade that anticipates community challenges and maximizes our ability to meet residents' needs in a rapidly changing world. The 10x goals for Vision 2026 include: eliminate homelessness, healthcare for all, employment for all, eliminate poverty and hunger, crime free community and accessible infrastructure.
