#### **Approval of Minutes**

  - Councilmember Chan directed staff to contact County Counsel regarding Nick Harvey's comments. # **Regular Calendar**

 Fill Importing Ordinance – Development of regulations for the importing of fill onto properties in the unincorporated areas of Alameda County – Action Item Rodrigo Orduna – Alameda County Planning Department

Rodrigo Orduna provided an overview of the Fill Importing Ordinance and discussed its impact in Fairview.

Kelly Abreu spoke regarding the impact of Fill Importing Ordinance.

Councilmember Silva motioned for the Fill Import Ordinance draft be approved as amended to include the following amendments on page 204 of the draft:

- For #2, add 'above' to 1 foot and above up to 10 cubic yards
- For #3, add 'above' to above 10 cubic yards and "up to a maximum of" 50 cubic yards; after county permission condition of use permit, add "notification to the neighbors", and
- For #4, add "above 20-50 cubic yards"

Councilmember Chan seconded - 3 ayes, 2 noes (Patenaude, Spalding)

#### 2. Census 2020 – Informational Item

Sophie McGuinness - Community Development Agency

Sophie McGuiness of the Planning Committee provided overview of Census 2020and its necessary procedures and processes for completion.

#### 3. Update on Fairview Logo Signage Survey Results – Action Item

Jaimie Orfanos – Alameda County Economic and Civic Development Department

Jaimie Orfanos provided an overview of the process for selection of the Fairview Logo Signage for final approval by the Council. A final survey was made available to the public for the following images: Rolling Hills and Water, Lone Tree, and Great Horned Owl. The results of the final survey were the following: 43 votes for the Rolling Hills and Water image, 45 votes for the Lone Tree Image, and 18 votes for the Great Horned Owl image. Ms. Orfanos and staff requested that the Council endorse a community selected icon for their logo.

Chair Higgins motioned to adopt the Lone Tree image. Councilmember Spalding seconded - 4 ayes, 1 abstained (Councilmember Silva).

### **Chair's Report**

Chair Higgins addressed questions regarding funding for the MAC's to come from the general budget and that it would be handled at the Board of Supervisors' level. He reported the Board of Supervisors took action on the Bike Shop, it has been approved and currently has permits pending. Chair Higgins reported on the Terrace View development, and that the City of Hayward will provide water, but at a higher rate. Chair Higgins reported that at the next Fairview MAC meeting, in addition to EALI item, the Council will cover the Rules and Procedures of the MAC, and requested to have EBMUD and PG&E report on issues in Fairview.

Councilmember Chan reported on the work on East Avenue sidewalks. On January 15<sup>th</sup> the Board of Supervisors approved a contractor for the sidewalks. The work will begin in March and end in the fall.
