Nick Harvey spoke regarding a drainage issue on Hansen Road causing damage.

Regular Calendar

 Fill Importing Ordinance – Development of regulations for the importing of fill onto properties in the unincorporated areas of Alameda County – Action Item Rodrigo Orduna, Alameda County Planning Department

Rodrigo Orduna requested action from the Fairview MAC to make a recommendation to the Board of Supervisors to adopt the draft ordinance for fill importing.

Kelly Abreu commented regarding the lack of enforcement of soil import.

Councilmember Spalding motioned to recommend that the Board of Supervisors adopt the Ordinance with the following modifications:

- Staff to provide a comparison between Marin and San Mateo Counties;
- Ordinance to include more detailed and updated Water Course Maps presently available at Public Resources such as the Oakland Library and Oakland Museum; and
- Ordinance to have a maximum on the cumulative fill height and/or amount and not receding the grades for the life of the property.

Seconded by Councilmember Patenaude – 4 ayes, 1 excused (Chan).

2. Fairview Area Specific Plan – Status and informational update on the preparation of the revised Fairview Area Specific Plan – Informational Item

Albert Lopez and Barry Miller presented a Fairview Area Specific Plan draft and provided an update on the plan.

Brenda Clarke expressed concerns regarding ordinance codes in Fairview and animal standards.

Bobby Clark concurred with Brenda Clarke's comments.

Kelly Abreu spoke regarding the Fairview Specific Plan Drafts.
