## **Summary/Action Minutes**

I. Addressing Homelessness in Alameda County

Lori A. Cox, Director, Social Services Agency, presented introductory comments and Elaine de Coligny, Executive Director, EveryOne Home, PowerPoint presentation on Ending Homelessness in Alameda County: Building a Coordinated Response.

The coordinated response system would ensure that homelessness is rare and brief and resolves people's housing crises efficiently. The target is that by the year 2020 the system would rehouse more people than the number becoming homeless. The goal is that no one spends more than 90 days homeless.

Lori A. Cox, Director, Social Services Agency, presented a PowerPoint presentation on the Emergency Shelter Update.

Shelter Standards guiding principles: Health & Safety, Equity & Inclusion, right to privacy, support services **Approach** 

• The Collaborative initiated a County-wide effort to stabilize funding for Emergency Beds through researching a flatbed-night rate.

## Methodology

- Research on bed-night rates were assessed on 5 communities (San Francisco, Sacramento, New York City, Massachusetts, and Bergen County, NJ).
- 18 Alameda County Funded shelters provided budgets that were analyzed through their participation in a survey.
- Based on Single Room Occupancy (SRO) rates, the Collaborative purposed a standard rate of \$34 bed-night. This is equal to dividing the fair market rent for an SRO unit (\$1,035) by 30 nights. This would be intended to cover the basic cost of shelter provision, not meals or services.

## Proposal

• Adopt a standard bed-night rate of \$34 a night for all SSA shelter beds.

Recommendation from the Social Services Agency:

- Approve Emergency Shelter Standards
- Adopt the standard bed night rate of \$34/night.
- Amend the current contracts to include the recommended RBA Measures.
- Continue to collaborate with County-wide housing efforts.

Linda Gardner, Director, Housing & Community Development, and presented a PowerPoint presentation on Addressing Homelessness in Alameda County.

The presentation included information on shelter beds available and associated costs, in addition to coordinated efforts with the City of Oakland and various County departments to address homelessness in Alameda County.

Kathleen Clanon, Medical Director, Health Care Services Agency, presented a PowerPoint presentation on Services to Homeless Encampments.

The Health Care Services Agency housing work focuses housing for people with physical and mental illness. On request from city or other agency partners with consent, the Agency uses names of individuals to find those eligible for our many services. In addition the Agency offers:

- Outreach to connect people with services
- □ IHOT behavioral health crisis team services
- □ Admission to sobering center/detox and transportation
- □ Street Medicine evaluation of those who are sick
- Urgent rehousing for high needs individuals
- **EMS** services.

Keith McWoodson gave testimony on his experiences being homeless. He stated that the biggest issues are affordable housing, mental health care and access to jobs. The Board members thanked Mr. McWoodson for his testimony.
