Summary/Action Minutes

I. Federal Legislative Update – CJ Lake

Congress will be in recess until December 3, 2019.

FY2020 Appropriations

Congress passed a second continuing resolution (CR) and President Trump signed it into law before the previous one expired on November 21, 2019. The CR included a few anomalies, including a delay of reductions in Medicaid Disproportionate Share Hospital allotments, repeal of over \$7 billion in FAST Act highway rescissions and a \$2.5 billion boost for the Census Bureau. The second CR funds the government through December 20th, giving Congress until then to complete the appropriations process or agree to another CR.

Census Funding

The CR funds the Census Bureau at a \$7.3 billion annual rate, about twice the Bureau's current funding rate. Of that funding, the CR includes language stating \$90,000,000 is for the delivery of Mobile Questionnaire Assistance Centers.

Appropriators reached a deal on spending allocations for all 12 appropriations bills. Reaching a deal on topline spending levels for each bill was a critical first step in finalizing appropriations bills.

Impeachment

The House Select Committee on Intelligence held five days of public hearings with nine witnesses on the impeachment inquiry of President Trump. Chairman Adam Schiff has said that while the investigation has not officially ended, the Intelligence Committee is compiling a report that will be sent to the House Judiciary Committee shortly after Congress returns from the Thanksgiving recess. If the Judiciary Committee finds sufficient evidence of wrongdoing, it will draft and vote on articles of impeachment. The articles of impeachment will then be sent to the House floor if they pass Committee. Democrats have stated that they are hoping to complete the impeachment process before the 2020 presidential primaries begin in February and well before the height of the campaign season.

II. State Legislative Update – Political Solutions

Week in Review at the Capitol

The Legislature and Governor continue to prepare for the 2020 legislative session. The Department of Finance is working closely with all state departments to ensure the Governor's budget is completed so it can be released before the January 10, 2020, deadline. The LAO released their annual fiscal outlook this week which shows a budget surplus of \$7 billion.

Governor Gavin Newsom

Last week Governor Gavin Newsom issued a statement regarding the Legislative Analyst's Office's annual state budget outlook, including the following: "California is now the fifth-largest economy in the world. Our state is proving what big-hearted, progressive governance can look like – all without breaking the bank. President Trump talks a lot about America's economic growth under his presidency, but when you look behind the numbers, you see that it's California's growth that has provided the economic rocket fuel for the nation."

County Sponsored Legislation

Political Solutions has received the PAL agenda for today's meeting and are actively reviewing the County's priorities and legislative proposals for the coming year. Once these proposals are adopted by the PAL Committee and the Board, the team will meet with the County's legislative delegation to identify authors for County sponsored legislation as we move closer to the Legislature's return on January 6, 2020.
