# **Summary/Action Minutes**

#### I. Federal Legislative Update – CJ Lake

#### Schedule

The House and Senate are in session this week. The House will meet for committee work, but no floor votes are planned.

#### Joint Session of Congress Address

President Biden will address a joint session of Congress on Wednesday. Due to COVID-19 restrictions, only around 200 people will attend the event in person. President Biden's main focus will be details of his American Families Plan. That proposal, featuring the biggest expansion of federal support for lower-income and middle-class Americans in decades, will be offset by a series of tax increases on the wealthy.

#### **Build Back Better: The American Families Plan**

The White House is preparing to unveil the second half of their Build Back Better agenda in the form of a roughly \$1.8 trillion spending and tax plan this week that includes many of President Biden's campaign promises. When combined with the American Jobs Plan, the approximately \$4 trillion in new spending would amount to being among the most ambitious government overhauls of the economy in decades.

As of now the proposal will include hundreds of billions of dollars for national childcare, prekindergarten, paid family leave and tuition-free community college, among other domestic priorities. The plan would also extend the robust child tax credit included in the American Rescue Plan until 2025, a measure that could cost as much as \$400 billion. As of last Friday, White House officials were planning to include a controversial provision that would provide around \$200 billion to extend an increase in health insurance subsidies through the Affordable Care Act exchanges. The plan will be at least partially funded by about a half-dozen tax hikes on high-income Americans and investors.

President Biden and White House officials have been adamant that the tax hikes used to pay for a portion of the Build Back Better agenda would not hit anyone earning under \$400,000 per year. The key tax changes are expected to include increasing the top tax rate from 37 percent to 39.6 percent; taxing investment gains from capital income at ordinary wage rates for those earning more than \$1 million; and imposing a higher tax on assets when they are transferred at death, among other provisions.

The Biden administration will try to get the Build Back Better agenda through Congress possibly by choosing to package the American Jobs Plan and the American Families Plan together or pass them individually.

#### **Census Apportionment**

Today, the Census Bureau released its count of state populations, reshuffling the 435 House seats among the 50 states to account for population changes over the last decade. Texas will gain two seats. Colorado, Florida, Montana, North Carolina and Oregon will also each gain a seat. Because the size of the House has been capped since 1911, seven slow-growing states: California, Illinois, Michigan, New York, Ohio, Pennsylvania, and West Virginia will each lose a seat. This marks the first time in California's history that the state will lose a seat in the House of Representatives. The apportionment count will also alter each state's representation in the Electoral College.

The average House seat will now represent 761,169 people, up from 710,767 from 2010. The Census also announced that the total U.S. population stands at 331,449,281 people, a 7.4% growth since 2010, but the second-slowest growth decade in U.S. history. The Census Bureau will release data that shows the growth in population centers that will guide states in redrawing their congressional district maps later this year.

# **Republican Infrastructure Proposal**

The main Republican criticism of President Biden's infrastructure proposals are that they are too expensive and too broad. Last Thursday, Senate Republicans outlined their own infrastructure proposal focused solely on transportation, broadband and water systems. The GOP package would cost \$568 billion, only about a quarter of the cost of President Biden's more than \$2 trillion package.

The Republican plan includes:

- \$299 billion for roads and bridges
- \$65 billion for broadband
- \$61 billion for public transit
- \$44 billion for airports
- \$35 billion for drinking water and wastewater systems
- \$20 billion for railways
- \$17 billion for ports and inland waterways
- \$14 billion for water storage
- \$13 billion for safety measures
