# **Summary/Action Minutes**

## I. Federal Legislative Update – CJ Lake

### **Congressional Schedule**

The House was in session at the end of last week for a series of votes, including legislation that would make some changes to the SBA's PPP program. June 30th is the first scheduled vote in the House, but they could return if necessary. Majority Leader Hoyer also noted Members would be given at least 72 hours' notice before voting on any further COVID-19 response legislation. The Senate returned today for five weeks.

### **House Schedule and Priorities**

On Friday, Majority Leader Hoyer released an updated calendar for the remainder of the summer. He announced that the House will be focused on committee work during the month of June, holding hearings, and marking up legislation. The goal is to have floor action later this summer on the FY21 National Defense Authorization Act (NDAA); an infrastructure package that includes reauthorization of the surface transportation authorization (FAST Act); a reauthorization of the Water Resources Development Act (WRDA); and FY21 appropriation bills, among others.

#### **Congressional Black Caucus Emergency Meeting**

Congresswoman Karen Bass, Chair of the Congressional Black Caucus, said the Congressional Black Caucus will be holding an emergency meeting today to determine their strategy and legislative agenda in the wake of the George Floyd protests and responses. Rep. Bass also stated that there needs to be a way to hold police officers and police departments accountable.

#### **Surface Transportation Reauthorization**

House Transportation and Infrastructure is planning to release their Surface Transportation Authorization bill this on June 3, 2020 The bill is scheduled to be marked up on June 17th. It will include three main titles, highway, transit and rail. The bill is broadly in keeping with the framework released by House Democrats in January.

### Budget

Last Thursday, the Assembly Budget Subcommittee 6 on Budget Process, Oversight and Program evaluation held an informational hearing to discuss the 2020 Budget. The Senate Budget and Fiscal Review Committee will be meeting this Friday, June 12. There is a sense of urgency as the June 15 constitutional deadline to pass a balanced budget is fast approaching.

### **Governor Gavin Newsom**

On Friday evening, June 5, 2020 Governor Newsom signed an executive order that will help increase the availability of over-the-counter drugs, hand sanitizer, and medical devices, such as respirators, ventilators and masks, which are in demand due to the COVID-19 pandemic.

The order also addresses a variety of other issues in response to the COVID-19 pandemic by extending several waivers to allow for flexibility placement of foster youth and critical programs. In-Home Supportive Services (IHSS) program caseworkers to continue their work caring for older adults and individuals with disabilities.

### **Department of Finance - Trailer Bill Language**

The Department of Finance (DOF) has begun posting May Revise Trailer Bill Language. They include the posting date next to each item to easily tell which ones are most current. The DOF has also posted an updated tracking sheet.
