#### II. State Legislative Update – Political Solutions

#### Week in Review at the Capitol

The Senate and Assembly adjourned late morning on July 11, 2019, with members returning to their districts on August 12, 2019. Policy committees met every day, with many committees meeting well into the evening leading up to the July 12, 2019, policy deadline. If a bill was unsuccessful in getting out it its respective policy committee, it will now be a two-year bill, unless the bill has an urgency clause or is a tax measure. When they return, they will be working toward the September 13, 2019, deadline for bills to pass prior to the end of session.

#### **Governor Gavin Newsom**

The Governor announced plans to appoint working groups of other regional leaders, service providers, formerly homeless people and academics around specific geographies or issues affecting homelessness, to work in collaboration with these advisors. These working groups may include experts on mental health, street homelessness or rural homelessness. Selection of working groups will be made in the coming weeks.

The group announced it will hold its first three regional convenings in the months ahead: August in the Central Valley, September in Southern California and October in Northern California. Exact dates, locations and working group presenters will be announced closer to the meeting times."

The advisors will examine best practices relating to prevention, diversion and intervention, as well as guide local governments as they develop regional plans to address homelessness.

#### **County Sponsored Legislation**

AB 723 (Quirk) Transactions and use taxes: City of Fremont: County of Alameda. AB 723 has been successfully amended to include the County in this bill, which will allow the County to the go to the voters should to decide to increase sales and use tax by .5%. This bill passed out of the Senate Governance and Finance Committee on Wednesday, July 10, 2019, and will be heard in the Senate Appropriations Committee when they return in August.

AB 944 (Quirk) CalWORKS: sponsored noncitizen: indigence exception.

County co-sponsored bill, AB 944 (Quirk) with the Western Center on Law and Poverty, was heard in the Senate Appropriations Committee on July 1, 2019, and was referred to the Suspense File, which will be taken up prior to the August 30, 2019, fiscal deadline.

AB 143 (Quirk-Silva) Shelter crisis: homeless shelters: Counties of Alameda and Orange: City of San Jose.

County co-sponsored bill, AB 143, was heard on May 1, 2019, in the Assembly Appropriations Committee, on the consent calendar. The bill was double referred to Senate Housing Committee and Senate Environmental Quality Committee. The bill was heard on Monday, July 1, 2019, in Senate Appropriations Committee and placed on the Suspense File to be taken up prior to the August 30, 2019, fiscal deadline.

The Political Solutions team continues to work with Assemblymember Eggman's office on identifying a legislative vehicle related to the Valley-Link issue (amendment to AB 758) in concert with Supervisor Haggerty's staff.
