MINUTES

1. **CALL TO ORDER** – Member DeGrange called the meeting to order at 6:30 p.m.

2. **PUBLIC COMMENT/OPEN FORUM/PUBLIC ANNOUNCEMENTS**

Jim O'Laughlin commented on the Niles Canyon Trail through Sunol. The presentation on the Niles Canyon Trail included information on Niles getting connected to the Trail but did not address Sunol getting connected to the trail nor how the trail would go through Sunol to get connected to the Water Temple, which was one of the main goals of the project.

Andrew Turnbull remarked on his appreciation that the Sunol Citizens' Advisory Council for having a predictable time and in a predictable way for citizens to give public comment. He thanked the Council for having Public Input at the start of the meeting, enabling people to participate and give their comments.

Kelly Abreu commented that CalTrans does not always use the highest standards when putting new bike lanes along roads. He wants the reply from CalTrans to be more in-depth in their response to the concerns that were expressed in the letter.

3. **REPORTS/UPDATES – Informational Items:**

Alameda County Sheriff's Office – Marc Petrini reported that five calls for service were received, another incident of mail theft occurred, and deputies are still patrolling to try to curb traffic.

Alameda County Fire Department – Bonnie Terra reported that 21 calls for service were received, most EMS or Service related. There were two vehicle fires. Two incidents occurred on 3/9, one was a vehicle fire and one that was an "unable to locate." CalFire Deputy Chief Mike Marcuccii reported on a call at Sheridan Road, near Andrade Road about a suspected controlled burn call.

Sunol Septic Working Group – Member DeGrange reported the consultant for the Work Group said that a report should be ready for the April meeting.
