- Created by the Homeland Security Act of 2002
- Currently 29 Urban Areas funded (Bay Area #5)
- Risk-based formula determines DHS funding
- Risk Methodology elements:

Threat: Likelihood of an attack


Vulnerability: Likelihood of a successful attack

Consequence: Effects of an attack

- 12 Counties Surrounding San Francisco Bay
- 3 Major Metropolitan Cities
- 8000+ square miles in the region
- 8,000,000 in population

The Bay Area UASI works with stakeholders to accomplish its mission:

- State (e.g., California Office of Emergency Services)
- Federal (e.g., FEMA, Department of Homeland Security)
- Private sector/quasi-governmental (e.g., EBMUD, PG&E)
- Nongovernmental (e.g., American Red Cross)
- Other regional organizations (e.g., Association of Bay Area Governments, Metropolitan Transportation Commission, Association of Bay Area Health Officers, Northern California Regional Intelligence Center)
- Bay Area UASI workgroups (e.g., Public Health and Medical, Emergency Management, Interoperability, Training and Exercise, Cybersecurity)



- Since 2006, the Bay Area region has received approximately \$340 million in UASI funds
- Last year the Bay Area received nearly \$23 million
- Development of regional capabilities to prevent, protect against, mitigate, respond to, and recover from terrorist attacks is a grant requirement
- 25% of funds <u>must</u> be expended on law enforcement & terrorism prevention activities

Project Proposal Process	All projects submitted by agencies, reviewed by hubs, and approved annually by the Bay Area UASI Approval Authority	January – June
Notice of Grant Award	Federal Notice of Funding Opportunity (NOFO) issuance is date- dependent on federal budget approval	FY 2019 may occur May 2019
Governing Body Resolution	City and County of San Francisco (fiscal agent) required to obtain legislative approval from SF Board of Supervisors to apply for funding	Annually, summer or fall
Application submitted to Cal OES by UASI Management Team	Management Team submits approved projects to Cal OES and applies for funding	Annually, approximately June
Preparation/Distribution of MOUs	Management Team delivers all MOUs for local government signature	Annually, each October/fall
Availability of Grant Funds	Grant funds become available after Cal OES issues official award letter/grant assurances and MOUs are fully executed	Annually, in October
Performance Period	Agencies allocated grant funds have a 14 month performance period as per their MOUs	e.g. FY 2019 funds must be spent by December 2020

A regional emergency response/homeland security training and exercise program is critical to the Bay Area

"POETE" (Planning, Organization, Equipment, Training, and Exercise) = FEMA requirement

Bay Area UASI regional stakeholders need and want:

- A robust, multi-disciplinary regional exercise to ensure readiness to respond to a disaster with regional impact
- A regional training program which saves the region money due to economy of scale

The Bay Area UASI will fund another provider per direction from our Approval Authority if Alameda County ceases to lead these initiatives.



Total annual UASI funding = \$4.9M

Urban Shield = \$1.7M

Training Courses = \$1.7M

• Staffing = \$1.5M

UASI funding allocated to Alameda County for the regional training and exercise program may only be used for these purposes and is <u>non transferable</u> to other uses.
