Pandemic Electronic Benefit Transfer (P-EBT)

- P-EBT ensures students receive an alternative to free or reduced-price (FRP) meals.
- P-EBT benefits are separate from CalFresh EBT benefits and do not impact CalFresh eligibility.
- Families are eligible for P-EBT if they:
- Include an eligible child or children, who would have received FRP meals, and
- The child's school has been closed for at least 5 consecutive days due to the public health emergency.
- Deadline to submit applications was July 15, 2020

- Countywide coordinated home delivery

The Food Bank would welcome more collaboration with a dedicated seat in the EOC dedicated to feeding the County and emergency food infrastructure, including personnel, County property and agency network reinforcements and capacity building.
