DEAR BUSINESS OWNER OR MANAGER:

Enclosed is your annual weighing and measuring device(s) and/or point of sale (POS) terminal(s) registration notice and fee for the period of January 1st – December 31st. Pursuant to Section 12240 of the California Business and Professions Code (BPC) and Title 3, Chapters 3.64 and 3.72 of the Alameda County Municipal Code (ACMC), each person responsible for the use of a commercial weighing, measuring and/or POS device(s) shall register their device(s) with the County Sealer of Weights and Measures annually. It is unlawful to operate a weighing, measuring or POS device without being registered for the current calendar year. Registering your device(s) helps to protect the buyer and seller from inaccurate or incorrect transactions

It is the responsibility of the device owner/user to ensure the device is maintained in proper working condition at all times. There will be a re-inspection charge for devices found to be incorrect on the initial or subsequent inspection(s).

DEVICE REGISTRATION FEE SCHEDULE:

General Weighing & Measuring Devices (Not Listed Below)	\$100 per location or vehicle + \$20/device (\$1,000 maximum per Location) + ADF \$1.10/device
Scales (other than Livestock) greater than 10,000 lbs	\$100 per location + \$250/scale + ADF \$12.00/scale
Scales (other than Livestock) 2,000 to 10,000 lbs	\$100 per location + \$150/scale + ADF \$8.00/scale
Scales (other than Livestock) 100 lbs to less than 2,000 lbs	\$100 per location + \$50/scale + ADF \$1.10/scale
Livestock Scales greater than 10,000 lbs	\$100 per location + \$150/scale + ADF\$12.00/scale
Livestock Scales 2,000 to 10,000 lbs	\$100 per location + \$100/scale + ADF \$8.00/scale
Computing Scales less than 100 lbs	\$100 per location + \$20/device (\$1,000 maximum per Location) + ADF \$1.10/scale
Prescription and Jewelry Scales	\$100 per location + \$80/scale + ADF \$1.10/scale
Stationary & Truck Mounted LPG Meters	\$100 per location + \$185/meter + ADF \$8.00/meter
Wholesale & Vehicle Meters	\$100 per location + \$75/meter + ADF \$1.10/meter
Vehicle Odometers utilized to charge fees	\$100 per location or vehicle + \$60/device (\$340 maximum per Location) + ADF \$1.10/device
Water Sub-meters	\$100 per location + \$2/meter + ADF \$0.10/meter
Electric Sub-meters	\$100 per location + \$3/meter + ADF \$0.10/meter
Vapor Sub-meters	\$100 per location + \$4/meter + ADF \$0.10/meter
Automated Point of Sale Terminals	\$150 per location for 1-3 scanners <u>or</u>
(Scanners)	\$225 per location for 4 or more scanners

A PENALTY OF UP TO 100% OF THE BALANCE OWED WILL BE ASSESSED FOR ALL LATE PAYMENTS. FAILURE TO PAY AND REGISTER YOUR DEVICE(S) MAY RESULT IN PROSECUTION BY ALAMEDA COUNTY DISTRICT ATTORNEY'S CONSUMER FRAUD UNIT.

CALL-BACK INSPECTION FEE SCHEDULE:

Small Capacity Scales	\$ 100.00 per hour + \$1.75/mile (up to 10,000 GVW)
Large Capacity Scales	100.00 per hour + \$2.50/mile (10,000 000 GVW)
(Scale exceeding 1,000 lbs capacity)	\$ 130.00 per hour + \$3.00/mile (more than 40,000 GVW)
Retail Gasoline Dispensers	\$ 70.00 per hour + \$1.00/mile
Wholesale Petroleum Meters	\$ 90.00 per hour + \$1.50/mile
Liquefied Petroleum Gas Meters	\$ 90.00 per hour + \$1.00/mile
All Other Commercial Devices	\$ 70.00 per hour + \$1.00/mile

NOTE: Charges are on a portal-to-portal basis.
