Jurisdictions which are eligible to receive federal funding from housing and community development programs administered by the United States Department of Housing and Urban Development (HUD) are required to prepare a **Consolidated Plan** which outlines needs, strategies, priorities, and programs for the expenditure of federal funds for housing and community development activities. The Consolidated Plan also combines the applications and reporting requirements for the Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), and HOME Investment Partnerships (HOME) formula programs. The Consolidated Plan is a planning document built on public participation and intergovernmental consultation.

For the purpose of receiving and administering HOME funds, the Alameda County HOME Consortium (Consortium) was formed in 1992 and includes the CDBG-entitlement jurisdictions of Alameda, Fremont, Hayward, Livermore, Pleasanton, San Leandro, Union City, and the Urban County (the jurisdictions of Albany, Dublin, Emeryville, Newark, and Piedmont, and the unincorporated areas of the County). In May 2020, the Consortium adopted a Five-Year Consolidated Plan for Fiscal Years 2020 through 2024.

The Consortium has prepared a **Consolidated Annual Performance and Evaluation Report (CAPER)** to assess performance during Fiscal Year 2020 under the federal programs covered by the Consolidated Plan. This report covers the period July 1, 2020 through June 30, 2021. It includes the Annual Performance Report for the HOME, CDBG and ESG Programs, and the Annual Performance Report by each of the entitlement jurisdictions assessing their performance according to the Consolidated Plan.

The draft CAPER will be available for review beginning September 1, 2021 **on the HCD website (see link below)** and on the websites the cities of Alameda, Albany, Dublin, Emeryville, Fremont, Hayward, Livermore, Newark, Piedmont, Pleasanton, San Leandro, and Union City.

The Draft FY20 CAPER will be available for inspection on HCD's Website: <https://www.acgov.org/cda/hcd/> beginning **September 11, 2021 on the HCD website. The public review period will end on September 15, 2021.** A public hearing will be held to receive comments on the FY20 CAPER on **Tuesday, September 14, 2021, 6 p.m.** The Hearing will be held via a Zoom meeting at the following link:
