#### 4) Director's Report

Secretary to the Board, Larry Brooks, acknowledged Black History Month and the work done by Lou Stokes who founded the Healthy Homes Movement.

Director Brooks gave an update on the Minor Home Repair/Rental Minor Home Repair/Lead Hazard Control Grants and the mass mailing promoting the grant programs sent out to property owners in priority zip codes in the Unincorporated County. As a result of the mass mailing, Mr. Brooks estimates that the Department will be able to meet the goal of 144 units for the Lead Hazard Control Grant program. Funds for the Rental Minor Home Repair program will be reallocated to our sister department, Housing Community Development.

Director Brooks spoke about the cuts being done in Congress for lead hazards. He has asked Lead and Healthy Housing Organizations to write letters to congress to reconsider these cuts.

Director Brooks reported on the Code Enforcement Board Meeting in February mentioning that attendees spoke about the implementation of Assembly Bill 838, Friedman, State Housing Law: enforcement response to complaints, which will require cities and counties to have a tenant complaint response program.

Director Brooks gave an update about California Mold and Senate Bill 655. There were webinars and trainings to encourage Code Enforcement Officers to comply and respond to tenant complaints about mold and moisture.

Director Brooks mentioned the dismantling of Rebuilding Together Oakland.

#### 5) Monthly Report

Lidice De La Fuente highlighted a focus group held in January on the topic of resources and programs to help pre-1978 property owners fix or maintain their homes. More information on new programs specific to county service area property owners will follow.

#### PUBLIC OUTREACH

Objective 1: By June 30, 2024, an estimated 5,000 Alameda County residents will be reached directly through multiple community outreach events and informed of CSA property owner services, lead safety, childhood lead poisoning prevention, training, maintaining a lead-safe property, minor home repair and the impact of housing on health. An estimated 2,945 individuals were reached through virtual collaboration meetings, presentations and trainings during July 1, 2023-December 31, 2023.

Objective 2: By June 30, 2024, an estimated 1,000,000 Alameda County residents will be reached through social media platforms, newspapers, radio, tv, emails, literature distribution and informed of CSA property owner services, lead safety, childhood lead poisoning prevention, training, maintaining a lead-safe property, minor home repair and the impact of housing on health. An estimated 705,744 individuals were reached during the first six months of the fiscal period through mailings, literature rack, social media and website visitors.

#### Community Outreach

- Staff participated in 56 collaboration meetings, nine community fairs and 12 presentations. In July, the Department participated in a tabling event at the Oakland Housing Authority Owner Appreciation Meet and Greet event. In Emeryville, staff participated in the Emeryville Fall Fest in the month of October and gave a presentation to the Emeryville City Council on property owner services. During this period the Department staff held multiple collaboration meetings with key partners to plan a soil lead testing event to be held in the first part of the new year.
- Provided 54 property based in-home consultations (3 Alameda, 21 Berkeley, 2 Emeryville, 28 Oakland). Property owners receiving a lead consultation also received a paint supply starter kit.
- Conducted 9 trainings reaching 104 individuals.
- In October 2023, the Department promoted National Lead Poisoning Prevention Week on multiple social media platforms, department website and radio media including Univision Radio and various radio stations owned by Bonneville.
- Multiple outreach activies were conducted to reach priority neighborhoods in the Unincorporated County using lead settlement funds. New partnerships to reach this population included San Lorenzo Food Pantry, Tiburcio Vasquez Health Center, REACH Ashland Youth Center, San Lorenzo Library, New Hope Church Food Distribution, St. John's Parish and My Eden Voice.

#### **COMPLIANCE**

Objective 1: Promote public policy and system change with healthy housing standards.

Objective 2: ACHHD will complete a standard operating procedure (SOP) regarding a formal enforcement process in cases of noncompliance with property based lead hazards identified. The purpose of this SOP is to improve compliance for properties with lead hazards (including unsafe renovations).

Collaborate with building officials, housing authorities, code enforcement agencies and contractors to address challenges to meet compliance.

• During this period the Department staff planned and coordinated with key stakeholders on the Western Region Lead and Healthy Housing Conference.

Participate in local, regional and state and Federal upstream planning on policy for meeting compliance.

• This activity is ongoing. During this period virtual meetings were held with the East Bay Rental Housing Association, California Department of Public Health; Anthem Blue Cross; Safe Kids Alameda County; Housing Authority of the County of Alameda, Berkeley Tobacco Prevention Coalition; West Oakland Community Collaborative; Alameda County Council for Age Friendly communities.

Provide Technical assistance to local jurisdictions on proactive rental inspections for lead hazards.

• No activity during this quarter.

Provide training opportunities to code enforcement officers in regards to State and EPA lead safety rules.

• In July, 13 City of Oakland Code Enforcement Officers received lead safety training in partnership with Natec International.

Update current Enforcement Response Policy (ERP) to reflect pertinent changes of the Cooperative Compliance model.

- During this period, ERP was being reviewed for updates/revisions (and is still in progress). Document should be ready for final review by early mid June. Reimplement the Case Review Working Group (CRWG), an interdisciplinary team that focuses on addressing compliance issues for identified property-based hazards (and potential unsafe remediations completed).
  - During this period, reimplementation was pending until hiring a full-time Registered Environmental Health Specialist (REHS). Once the REHS obtains the Inspector/Assessor certification (anticipated mid-May 2024), the CRWG will be formally reimplemented.

Collaborate with the Alameda County DA office to establish formal referral policy and procedure for ongoing compliance barriers for property-based lead hazards identified.

• During this period, enforcement collaboration was ongoing and active. No activities to report on establishing a formal referral policy.





#### Report for February & March 2024 Public Outreach


By June 30, 2024, Alameda County residents will be reached and informed of CSA property owner services, lead safety, childhood lead poisoning prevention, training, maintaining a lead-safe property, minor home repair and the impact of housing on health. Direct outreach to an estimated 5,000 residents will be done through community events such as presentations, information booths, trainings, and lead consultations, etc. An estimated 1 million individuals will be reached through multi-media campaigns (radio, T.V., social and print), collaboration meetings, mailings, webpage, etc.





#### **Healthy Housing Assessments/Interventions**

By June 30, 2024, a total of 455 healthy housing assessments / interventions will be conducted in the homes of Alameda County residents participating in the Lead Hazard Control Program, Lead Poisoning Prevention Program, Minor Home Repair programs, Fixing to Stay and Independent Living Homes Project or when responding to unsafe renovation condition complaints.
