Director John J. Bauters chaired the meeting at 9:19 A.M.

1) Open Forum

2) Director's Report

Soni Johnson, Healthy Homes Community Development Specialist informed Directors of an unsafe renovation complaint in the City of Alameda where extensive remodeling had been conducted at a historic home near a school without lead safe work practices. Ms. Johnson confirmed that the contractor was not EPA Renovation, Repair, Paint (RRP) certified and it was unclear whether the contractor was aware of the RRP acknowledgment form that the city of Alameda originated and implemented in 2014. Director Mary Hatsume Vella asked staff for information on findings to discuss with Alameda Building officials and recommended a proactive approach by the Department including reaching out to neighbors and school with information on childhood blood lead testing, lead renovation and certification requirements, process and training.

Secretary to the Board, Larry Brooks and Soni Johnson also informed Directors of unsafe renovation complaints in Oakland, Berkeley and in Castro Valley. A contractor conducting unsafe lead work practices in Oakland was enrolled in an RRP course; the Department collaborated with the City of Berkeley Building Department on a stop work order; and, as a result of staff involvement at an unsafe renovation response in Castro Valley the contractor placed proper containment around the property as required by law.

Director Susan Wengraf noted that repainting does not require a permit, however, preparation of surfaces may be a problem with disturbing lead based paint. Larry Brooks acknowledged the problem and reiterated the importance of training building inspectors and code enforcement officers on RRP as well as implementing routine proactive rental inspection programs.

Mr. Brooks indicated that 25 individuals are now RRP certified as a result of attending the RRP training held in Emeryville on July 11th, 2018. In attendance were city officials representing the cities of Berkeley, Emeryville and Oakland. Mr. Brooks invited City of Alameda officials to participate in the next RRP training scheduled for October 2018 in Monterey, CA.

3) Outreach and Education Monthly Report

Lidice De La Fuente reported on the outreach and education report for June 2018. Ms. De La Fuente stated the Department is verifying the total number of interventions for the fiscal year and will provide an accurate count at the next JPA meeting. Soni Johnson stated the Safe Kids event at the Oakland Coliseum held on June 23, 2018 was successful and well attended resulting in an increase of lead poisoning consultations for the Department.

Director Vella recommended the Department staff reach out to Alameda's Renters Coalition to inform tenants of lead poisoning prevention.

Director John J. Bauters asked for additional information on the six healthy home assessments conducted in Emeryville. Ms. De La Fuente stated she would follow up.
