Mr. Brooks expressed his apprehension for the expenditure and recommends allocating some of those funds to Childhood Lead Poisoning Prevention programs. JPA Directors expressed interest in learning more about the issue and asked for a short report indicating the efficiencies and inefficiencies and its impact.

Mr. Brooks announced that the Department is hiring for a Community Relations Coordinator.

Ms. De La Fuente reminded Directors that the stipend checks are good for up to six months. She also stated that there may be some changes to the process for completing the stipend claims, which Ms. De La Fuente will work directly with each Board member once more information is available.
