Director John J. Bauters opened the Program Operations Committee Meeting at 9:25 A.M.

#### 2) Director's Report

Dale Hagen, Housing Services Manager stated Secretary to the Board, Larry Brooks, was unable to attend the JPA meeting due to the California Association of Code Enforcement Officers Board Meeting where he is supporting lead safety initiatives.

Mr. Hagen provided an update on the close out of the Lead Hazard Control grant (HUD 24), projecting 147 final housing units made lead safe, 27 units over the grant objective; 168 units were lead tested and 228 individuals were trained on lead safety including six individuals associated with a lead poisoned child and two individuals associated with a housing rehabilitation program.

The Department received a \$3.6 million-dollar grant for 3.5 years to conduct lead hazard control in 144 housing units including \$600,000 for healthy housing repairs. Currently, the Department has 40 units on the interest list, which staff will reach out to complete application process with to begin approving construction projects in March 2020.

# 3) Outreach and Education Monthly Report

Lidice De La Fuente highlighted 30 housing assessments/interventions in Oakland noting that the contract for minor home repairs in Oakland was recently approved. Also, trainings were conducted including the two-day Lead Supervisor training, Lead Safety and RRP training. Additional trainings will be conducted in January and February including an Integrated Pest Management training.

Director John J. Bauters opened the General Board Meeting at 9:40 A.M.

#### 1) Open Forum

#### 2) Director's Report

Healthy Homes Manager, Dale Hagen, informed Directors that in November 2019 the EPA banned the consumer sales of Methylene Chloride used in paint and coating strippers that has been linked to dozens of accidental deaths. Directors expressed concern of the general public being exposed to the chemical and made recommendations for Department staff to take extra efforts to inform the public. Recommendations included posting announcement on the Department's website; include key messages as part of Department outreach on what products may contain the chemical and how to dispose of the product. Additionally, Directors asked for staff to report back what steps the Department will take to inform the general public and information on types of products that may contain the chemical.

Mr. Hagen reported on California's new lower lead dust standards, revising Title 17 in relation to environmental investigations involving lead poisoned children. Mr. Hagen noted that the U.S. Department of Housing and Urban Development already adopted these new standards for Lead Hazard Control grants.

Furthermore, Mr. Hagen stated that according to the California State Audit report on blood lead testing the State is not doing enough for children covered under Medi-Cal and should do more to identify high risk areas. Recommendations made were to adopt lead testing performance standards and identify untested children and their medical providers. Mr. Hagen indicated that the Department conducted lead screening outreach in the Unincorporated area of the County and found good compliance with blood lead testing. Director Gwen Hardy stated more lead testing needs to be done and emphasized the need for additional outreach and awareness in the medical community and to educate parents to demand blood lead testing for their children. Director Bauters asked Department staff for a report back on why providers are not doing enough blood lead testing; whether children under the age of three are not receiving service or if the children are not having their annual check-ups; reimbursement coding for medical providers; and data where unscreened kids are located to identify if there's a geographic nexus.

Ms. De La Fuente announced that the next meeting is February 27, 2020 at 9:15AM at Emeryville City Hall.
